"URGENT ACTION"

Gentle People:

This letter is lawful notification to you, pursuant to The Bill of Rights of the National Constitution, in particular, the First, Fourth, Fifth, Sixth and Ninth Amendments, and The Bill of Rights of the New Mexico Constitution, in particular, Article II, Sections 1, 2, 3, 4, 17 and 18, and pursuant to your oath, and requires your urgent action to vote and speak up on behalf of and representing the People and environment of New Mexico and the Nation specific to the subject matter of this letter.

As elected and appointed Representatives of the People, the Sovereigns in this Nation, you are required, pursuant to your Oath and Constitutional mandates contained therein, to uphold rights guaranteed in the Constitution to the People, to act in the Public Interest and to Uphold the Public Good. **Nuclear contamination is in direct violation of Constitutional Requirement and Rights guaranteed to the People.** You as elected representatives in government and Government are required to deal and act lawfully with the People. Yet, by your own actions, you have dealt unlawfully with the People and officially oppose their Rights, their Best Interests and their Good.

Your failure to respond within 30 days, as stipulated, and rebut, with particularity, everything in this letter with which you disagree is your lawful, legal and binding agreement with and admission to the fact that everything in this letter is true, correct, legal, lawful and binding upon you, in any court, anywhere in America, without your protest or objection or that of those who represent you. Your silence is your acquiescence. See: *Connally v. General Construction Co.*, 269 U.S. 385, 391. Notification of legal responsibility is “the first essential of due process of law.” Also, see: *U.S. v. Tweel*, 550 F. 2d. 297. “Silence can only be equated with fraud where there is a legal or moral duty to speak or where an inquiry left unanswered would be intentionally misleading.”

We are Citizens of the American Constitution, a patriotic group of loyal American Citizens, who advocate for the Rights of all Citizens and who have a duty to oppose all enemies of this Nation, foreign and domestic. Our group has won well over 306 cases in New Mexico courts, with few losses, and those are won on appeal. The Constitution is the Supreme Law of this land and few judges dare to oppose it, on the public record. Will you oppose it?

It is with heavy hearts that we write this letter. There is no mercy for the people of New Mexico. We have been the SACRIFICE STATE for the trash that causes death and destruction of the nation and the world. Our nation affirms God in its documents and Oaths, yet we abuse His charge to take care of Earth and all the creatures thereof. Do we also in that same breath deny His Power? On June 30, 2009, the EPA held a recertification hearing for WIPP. Despite having received unfavorable reports compiled by objective scientific experts, the individuals responsible for bringing about WIPP ignored the scientific data and pushed WIPP forward, based upon a hypothetical model which recently analyzed hard scientific data, collected by the Department of Energy, now clearly shows was tragically incorrect. **Any public official should be sentenced to life in prison if they allow this recertification to be approved again.**

***Mother Earth already has a degree of fever caused by radioactivity not greenhouse effect nor missing ozone. That one degree has already upset the earth's metabolism enough to cause many fish in the seas to migrate into colder waters. It is causing ice caps and glaciers to melt, etc. Actually the increase registers a bit more above one degree and rising. Less than ten more degrees of radioactive fever will make of our planet a barren wasteland. The***





United States of America only uses 20% of nuclear power which has contaminated the ecosystem of the United States AND THE WORLD. Nuclear Energy is the most expensive way to boil water. We are in a nuclear holocaust. We must phase out nuclear power plants. All atomic activity must cease upon the earth. There is no safe way of storing the waste or disposing of it, and nuclear facilities are making too much of it. **This is the greatest crime to humanity and all life on the planet and the universe.**

Because of so much uranium in New Mexico and surrounding states, our ground water has high radon readings. For instance, Farmington is at 323pc, Taos 2,122pc, Raton 828pc, Santa Fe 861pc, Carlsbad 175, Silver City 753pc, Clovis 646pc, Ruidoso 743pc, Grants 596pc, Tucumcari 881pc, and Las Vegas 1,056pc. **According to Environmental Protection Agency standards, radon should be lower than 200 picocuries (pc) per liter. So, naturally the radioactivity in our water is already high.**

Uninformed witness and Senior Policy **Analysist Ben Liberman** lied that there were zero emissions from power plants. In addition to being a known carcinogen, Sr-90 is also a marker for the 100+ radioactive chemicals that are released in nuclear reactor operations, but it is a critical one. Like calcium, Sr-90 (strontium) attaches to the bone and teeth when it enters the body, where it remains for many years due to its slow rate of decay (half-life of 28.7 years) and the slow rate of removal of calcium in bone, typically with a 5-10 year half-life in adults and 2 years in infants. Sr-90 kills and impairs bone cells, and penetrates the bone marrow, in which the white blood cells critical to immune function are formed, making it a risk factor for all cancers. **Radioactive krypton** is released in the daily operation of **nuclear plants** and in still larger amounts through the reprocessing of burned-out nuclear reactor fuel elements. The amount of this isotope entering the atmosphere climbing at a rate of five percent per annum, and it has already affected the distribution of electric fields in the atmosphere.

***The release of radioactive gases alone changes the frequency and distribution of global precipitation.*** Xenon is another dangerous radionuclide emitted from **nuclear plants**.

## W A T E R I S L I F E.

*The RPHP "Tooth Fairy Project-" grew out of the work of **Dr. Jay Gould**, Director of the Radiation and Public Health Project (RPHP) and author of *The Enemy Within: The High Cost of Living Near Nuclear Reactors*. By analyzing 50 years of US National Cancer Institute data, Dr. Gould proved that...*

*"...of the 3,000-odd counties in the United States, women living in about 1,300 nuclear counties (located within 100 miles of a reactor) are at the greatest risk of dying of breast cancer."*

*Dr. Gould found even higher risks for prostate cancer among men living in nuclear counties. Since their inception, nuclear power plants and bomb facilities have*

been emitting fission products through accidental releases and through regular allowable emissions that the government classifies as below regulatory concern. Radioactive Strontium-90 (Sr-90) is one of these elements, and one of the deadliest. The chemical structure of Sr-90 is so similar to that of calcium that the body gets fooled and deposits Sr-90 in the bones and teeth where it remains, continually emitting cancer-causing radiation, neurological damage, and poor brain function. Dr. Ernest Sternglass, lifetime researcher, discovered that diabetes, heart disease, etc. are linked to low level radiation exposure, and that no level is safe. Diabetes has escalated and is rampant in the United States and the world. It's primary cause is because of the nuclear test bombs, nuclear detonations in war, and the waste transported on our highways throughout the world. (See #1 below also.)

In June 2009, misinformation and gross lies abound in our USA Capital. **Dr. Theodore Rockwell**, a professional misleader, **lied** before Congress and was asked if nuclear waste had ever harmed anyone. He said, "In the real world, who do you know who has been hurt by nuclear waste... It's not hurting anybody...No impact on the earth whatsoever..." **Who has bought off Liberman and Rockwell? The Devil?** We can only suppose that he has never heard of Hiroshima, Nagasaki, Chernobyl, Three Mile Island, WIPP, Yucca Mountain, & (1000's more) and has never heard or read of any documentation from the hundreds of other well educated, informed, research studies published in the United States, and the world. **Dr. Ernest Sternglass** documents changes due to nuclear waste, production, contamination, and ultimately death with hundreds of so called common diseases in between. Health Care costs were in the billions and now is in the trillions. It has gone up a 1000% because of the side effects of nuclear production and waste transportation and nuclear explosions. ***And in the state of New Mexico, this is what waste and radiation has caused.***

The following are **additional** areas of this invisible, uncontrollable, deadly, nuclear radiation left as an **environmental catastrophe in New Mexico** by the corporations who previously mined uranium in New Mexico and left this state and nation without any Clean Up and No Radiation Monitoring of the Waste.

1. **Los Alamos National Laboratories (LANL)**: The LANL facility was constructed on several **major fault lines** and is very close to the **Jemez Volcano**. LANL **Illegal** Nuclear dump has over two million 55 gallon drums of radioactive materials stored above ground. Some are corroded and leaking. This nuclear dump is larger than the Waste Isolation Pilot Plant and has over a hundred air stacks which emit radioactivity are not monitored; numerous off-site contamination and dumps; one of three nuclear reactors possibly in operation; and LANL is accountable for more than 60 years of contamination. Numerous studies by the community groups, the New Mexico Environment Department and

LANL, itself show that New Mexico's future water supply is threatened by highly toxic pollutants, including PCBs at more than 25,000 times the New Mexico Water Quality Standard protective of human health. Other toxins of critical concern include hexavalent chromium, the same carcinogenic compound featured in the movie *Erin Brockovich*; perchlorate, a chlorine-based chemical linked to thyroid dysfunction; high explosives and numerous radioactive elements. Detections of radionuclides in Los Alamos County and the City of Santa Fe drinking water wells were included in two Department of Energy documents evaluating the environmental impacts of operations at LANL. The data for these documents was taken from LANL's water quality database. Detected radionuclides include americium-241, cobalt-60, cesium-137, plutonium-238, 239 and -240, strontium-90 and tritium that have been detected in the regional aquifer. Elevated levels of toxic hexavalent chromium were first detected in a regional aquifer well in January of 2004. LANL reported the detections to the New Mexico Environment Department (NMED) two years later in December of 2005. During that time the detected chromium levels nearly doubled from 270 parts per billion (ppb) to 405 ppb. Since then the levels at that well have fluctuated around 400 ppb. The New Mexico Drinking Water standard is 50 ppb. LANL announced that during their chromium investigation they detected the presence of molybdenum along the assumed travel pathway. First chromium and later molybdenum was used as corrosion inhibitors at LANL's Omega West Reactor and both were discharged into the canyons. Their presence indicate that the travel time for a fast moving contaminant from canyon bottom to the regional aquifer may be between 25 and 30 years. Molybdenum is a metal, which can be toxic when ingested at high levels. Molybdenum blocks the absorption of zinc and copper and has been found to irritate the eyes, nose and throat, as well as cause diarrhea, weight loss, and liver and kidney damage; elevated rates of brain and child cancers and thyroid cancer triple normal rate. All Nuclear, Biological and Chemical Warfare Production, Dumps, and Open Burn of Nuclear Waste and Detonation must cease **NOW**. **PURSUANT TO YOUR OATH, IT IS YOUR RESPONSIBILITY AND DUTY TO CLEAN ALL THIS UP.**

2. **WIPP** Waste Isolation Pilot Plant in the **Carlsbad** Area: WIPP will accommodate one million 55 gallon containers of radioactive materials. Entombment is unsafe in an area where water has leaked into the salt caves and corrodes the containers which then follows the karst terrain throughout **America to Canada** as well as down into **Mexico**. Science has been ignored, here, because this is the largest karst terrain in this hemisphere of the earth and is the most dangerous terrain to store nuclear waste. DOE, EPA, Federal and NM state officials have ignored science

and have endangered the health and safety of the people of New Mexico and the World. Located near WIPP is one of the largest **Dairy Farms** in the United States. In the area close to WIPP there are over fifty more dairy farms. All around the WIPP site is drilling for potash, oil and gas. The DOE breached the WIPP site with their own drilling. There is evidence of water falls down in the WIPP site.

3. **Shiprock and Farmington** area: Lung, gastric, bone and reproductive cancers, miscarriages, stillbirths, congenital malformations, kidney disease, diabetes, heart and neurological disease have been identified as being related to uranium mining and milling by recent **Navajo Health Study**.
4. **Grants Uranium Belt**. 40% of all US uranium mines are in the area of **Gallup, Grants, Laguna and Acoma**. *There are 1,300 abandoned uranium mines and buried waste remains*. Mining process has contaminated groundwater and several unlined surface ponds from which the animals drink and ultimately contaminates the whole food chain. Winds blow radioactive particles from tailing piles throughout the area (and world). Plutonium has a life span of 250, 000 years. A microgram is lethal. Wind particles can lodge in lungs or travel to organs resulting in cancer. **Stop** all test wells and destabilization of any mined area.
5. **Radioactive Rivers**: Ongoing contamination from uranium in both of the **Rio Puercos, the Rio San Jose, The Rio Paguate, the Paguate Reservoir, the Rio Moquino, and the RIO GRANDE** down to **Elephant Butte**. High concentration of uranium contaminated silt in the **Paguate Reservoir**.
6. **Socorro Area**: Depleted uranium weapons range contaminates large areas of water and land.
7. **White Sands**: Site of the first above ground nuclear test is still radioactive with fallout still being detected (50 or more years according to research), but open to tourists. Pregnant women are advised to stay away. Fallout from this and all other nuclear test is in the adobe and in the dirt in the attics of old New Mexico homes.
8. **Gnome Project**: 1961 underground nuclear bomb test in which a large radioactive plume escaped into the air.
9. **Cochiti Lake**: Plutonium found in the lake. **Close the Lake down!**
10. **Los Alamos Fire**: A third of Los Alamos Labs burnt down and thousands of acres offsite were poisoned and destroyed. Tons and Tons of Nuclear radiation and hazardous chemicals were burnt in the fire. Wherever the ash fell, the area is radioactive. People were offered a few hundred dollars for polluting and poisoning their land and air and water. Animals, plants, trees, drinking water, air, and all residents have been affected down-wind and down-stream from US nuclear, biological, chemical, weapons production and radioactive waste disposal sites. Open burn and


detonation are certainly not to the benefit of the People - are, in fact, to their detriment - and treason to the People of New Mexico and the Nation. Even before the fire, the Los Alamos Study Group found plants and trees emitting radiation. Therefore after the fire, more radiation was released into all areas where the smoke traveled infecting five states simultaneously. Hospitals in New Mexico report that 80% of patients are affected by diabetes. Diabetes is linked to radiation exposure. The hospital beds are so full in NM that sick people are being air lifted to Colorado, Arizona, and Texas.

**11. Albuquerque:** Plutonium in the soil of UNM, the zoo, several parks and school. DOE has dumped radioactive waste into the sewer which flows into the **Rio Grande**. There are 26 sites of radioactive materials, toxics, and explosives at an old nuclear weapons assembly site in **Sandia National Laboratories**. **Kirtland Air Force Base** is also burning nuclear and hazardous chemicals and is not monitoring the air in Albuquerque. They are emitting alpha particles, which is nuclear radiation. This is affecting not only Albuquerque, but the nation. This radiation fallout is poisoning the surface water of the Rio Grande (already contaminated from LANL, Sandia, and Kirtland) which is the drinking water of Albuquerque and anyone else along its course. They are violating the clean air and water act. Kirtland Air Force Base has nuclear fuel rods on site. Albuquerque (population of over 600,000) is the home of the second largest nuclear arsenal in USA. Housing over 2,000 nuclear weapons, all lacking safety devices, constitutes roughly one-fifth of the US nuclear arsenal. Albuquerque has a unique role to play in disarmament. *If Albuquerque were to secede from the union, it would be the world's third largest nuclear power: Russia, USA, and Albuquerque.*

**12. I-25/I-40:** Trucks are carrying robotic, radioactive, and toxic cargo. Waste planned for WIPP in New Mexico is traveling across the nation. Research shows that the more the animals and people are radiated, **the more violent they will become.**

**13. Triassic Park** (Proposed): Global High Nuclear Waste Dump. **KEEP IT OUT!!!**

**14. Eunice :** A Uranium processing plant. *Eunice is also karst terrain which is going against Science and Law again.* The state of New Mexico never approved the Eunice processing plant. The Nuclear Regulatory Commission (NRC) had no authority and broke the Law by permitting the Eunice plant to be built.

 **In light of the gravity of this situation, we fully expect you to carefully consider your sworn duties to the Constitutions and to the powers of and the Rights guaranteed therein to the People of NM&USA. If you think that you must comply with the "directives" of the federal government in this matter, over and above the**

welfare of the People of New Mexico, you are incorrect, because the federal government may not compel the states to enact or administer a federal regulatory program. (See: Printz and Mack v. U.S., 66 F.3d 1025 (9<sup>th</sup> Cir. 1995.)

15. Because of all this nuclear activity in the state of NM, we are the **number one target for terrorists**. We are being **terrorized by our own government** and paying for it with our tax dollars and our health and safety.
16. When radiation hits a female, it travels around the body, and when it settles, it goes to the soft tissues which are the woman's breast. **Breast cancer** has steadily increased over the years. In the male, it goes to the soft tissue which is their prostate which causes **prostate cancer**. All of this leads to possible devastating consequences medically, as well as loss of sex drive, and causes **sterility**. Radiation exposure **mutates the DNA in both sexes**. When this happens to adults, it happens even faster in children who are much smaller causing **physical and mental handicap & debilitation**. It is proven and documented how Diabetes is also caused by radiation. **Diabetes** is the leading cause of amputation. Nuclear radiation causes fatigue, muscle & joint pain, memory loss, hair loss, severe headaches and blindness.

## *This is criminal and Outright* **GENOCIDE.**

We already know the dangers of **nuclear radiation exposure**. We demand **FREE MEDICAL HELP FOR OUR SOLDIERS, OUR PEOPLE, and OUR ANIMALS**.

We demand radioactive monitoring devices for all communities along the W.I.P.P. route and near nuclear facilities.

We demand an independent investigation of W.I.P.P. and all nuclear facilities in the state of New Mexico and around the nation.

We demand compensation for contaminating our people, animals, land water, and air in New Mexico with nuclear radiation.

We demand a moratorium on all production of nuclear energy; nuclear, biological & chemical warfare, open burns of nuclear waste and chemicals, open detonations, and chemical-trails here in New Mexico, the Nation, and around the World.

**Pursuant to Your Oath,**  
**IT IS YOUR DUTY AND RESPONSIBILITY TO CLEAN**  
**ALL THIS UP.**

**We Demand the SUPERFUND !!!!!!!**

Because Nuclear, Biological, and Chemical Production and Waste, Open Burn and Detonation is **insane, irresponsible**, a disgrace and poses immediate and



long-term grave dangers to our health and environment, there is no Constitutional authority for NMED & EPA allow these actions in reckless disregard for the People of New Mexico and the Nation and the World, in direct opposition to their welfare and in breach of the Public Trust. As a result, we demand that NMED& EPA, State and Federal Elected and Appointed Officials **oppose nuclear, biological, and chemical production and waste.**

Any and all public officers, departments and agencies of the State of New Mexico, whether elected or appointed, work for the Citizens of New Mexico and receive per diem or salary from those Citizens. In exchange for the Public Trust of those Citizens, you have sworn oaths to support and uphold both the Constitution for these United States of America and the Constitution for the Republic of New Mexico. We direct your attention specifically to the State Constitution, in particular, Article II, Sections 1, 2, 3 and 4, which respectively state that: (1) the **National Constitution is the supreme law of this land;** (2) **that all political power is vested in and derived from the People: all government of right originates with the People, is founded upon their will and is instituted solely for their good;** (3) the People have the sole, exclusive Right to govern themselves; (4) all People are born equally free with inherent, inalienable Rights, including, but not limited to, those of defending and enjoying life, liberty, property, safety, and happiness. We further direct your attention to Article XX, Section 21 of the State Constitution which requires the state legislature to provide for control of pollution and prevent despoilment of the air, water and other natural resources of this state for the maximum benefit of the People. The nuclear production is also in violation of Article VI of both the United States Constitution and the **INTERNATIONAL Nuclear Non-Proliferation Treaty (NPT)**. Article VI of the NPT calls for the elimination of nuclear weapons. We must stop the production of new nuclear weapons in our state, the nation, and the world, and focus on cleanup of past contamination from nuclear weapons production and support peaceful conflict resolutions. The number one product we sell to the world is weapons. Wars must be created to sell the product. **Ultimately we are killing ourselves.**

**Article II, Bill of Rights, Section 5, Rights under Treaty of Guadalupe Hidalgo preserved. "The rights privileges and immunities, civil, political, and religious guaranteed to the people of New Mexico by the Treaty of Guadalupe Hidalgo shall be preserved inviolate."**

Your oath is your attestation that you know the Law and will faithfully abide by it, and to ensure that you do so, you are required in Article XXII, Sec. 19, of the State Constitution, as well as in NMSA 10-2-1 to 10-2-15, to give bond for the faithful performance of your duties as a condition precedent to assuming office. This Constitutional requirement supersedes subsequent statutes and cannot be repealed except by an Act of Congress. Pursuant to your oath and your bond, you are responsible to the People of New Mexico and are required to act in their best interest and not for the interests of the military-industrial complex and uranium mining corporations, well represented in New Mexico & the USA. ***Ike was right!***

By supporting and voting for nuclear production and waste, you have already perjured your oath, committing sedition and insurrection to the Constitutions, and treason against the People. By your actions, you have invoked the self-executing Sections 3 and 4 of the 14<sup>th</sup> Amendment to the National Constitution, thereby immediately vacated your office and forfeited any pension and benefits thereof. In addition, you are a domestic enemy and subject yourself, personally, and in your professional capacity, to both criminal and civil prosecution for your crimes. You have lost any perceived immunity, your former employer will not protect you and you stand on your own.

However, pursuant to your oath, you *are* compelled to uphold the Public Trust by opposing nuclear production and waste, from callously endangering the health and safety of the Citizens, (whom you purportedly serve), destroying the environment of New Mexico and the world, and that of any other entities that will be affected by fallout which will permeate everywhere. We, in **Las Vegas, Albuquerque, and Santa Fe**, are especially concerned because we drink surface water which is being contaminated by this radioactive fallout – and all communities along the Rio Grande. Crops like our chile that require irrigation along the Rio Grande and our acequias are also affected.

We urge you to act on behalf of the Citizens you are sworn to serve: to **oppose** the Manufacture of **Nuclear, Biological, and Chemical** Weapons, Nuclear Dumps, Open Burn/Detonation, AND forbid any future action regarding nuclear radiation and mining and production in New Mexico and the Nation. If you fail to reverse your unconstitutional actions and do not stop this very real threat to the health and well being of the People of New Mexico and the Nation, then, We, as Citizens sworn to oppose and expose all enemies of this land, both foreign and domestic, shall not hesitate to file criminal charges and bring civil actions against you, personally, and in your professional capacity, for your **crimes against the People of New Mexico, the Nation, AND THE WORLD.**

The Navajo Nation ( not just one tribe, or only in New Mexico, but the **Nation of Navajos**) has put a moratorium on the mining of uranium on their land because it is poisoning their environment and devastating their health and damaging their DNA and also causing sterility in the human race and the animals. Studies have shown that the **Navajo and New Mexicans** have suffered tremendously because of contaminated ground water and winds blowing radioactive particles from tailing piles throughout the areas. Rio Puerco in 1979, near **Church Rock is the site of the largest radioactive spill in the nation** – **PURSUANT TO YOUR OATH, IT IS YOUR RESPONSIBILITY AND DUTY TO CLEAN ALL THIS UP.** **The invisibility of this contamination is infusing New Mexico and all mother earth and the universes.** High levels of radium found in **Navajo** residential properties cause fractured teeth and bones, and other cancers, cataracts, and anemia. The **Navajo Nation** has created this **GLOBAL DECLARATION** as they desire to protect all people and **Mother Earth.**

*The very fabric of creation is endangered, our school yards.*

## *This is a most crucial time.*

*I, Catherine F.
