## National Commission on Hunger hosts public hearing in El Paso, TX

El Paso, TX (June 19, 2015) — The National Commission on Hunger invites the public to provide input on how to ensure Americans have access to sufficient, healthy food. Public testimony will inform the Commission's recommendations to Congress and the U.S. Department of Agriculture (USDA).

The 10-member National Commission on Hunger is a congressionally appointed bipartisan commission charged with developing innovative reforms in both public and private food assistance programs to reduce or eliminate food insecurity. The recommendations are meant to include ways to more effectively use USDA programs and funds. As part of



its information-gathering process, the Commission is conducting a series of public hearings across the country.
