

INSTRUCTIONAL RESOURCES FOR THE SIDEWHEEL STEAMSHIP JOSEPHINE

A STEAMER FROM HAVANA GOES TO PIECES NEAR THE MISSISSIPPI COAST—NO LIVES LOST!

This was the headline from a New Orleans newspaper on the morning of February 9, 1881. The steamer was the sidewheel merchant ship *Josephine*. She was sailing from Havana, Cuba, to New Orleans, Louisiana, when she FOUNDERED during a severe winter storm. Though all of her 65 passengers and crew survived, the shipwreck may still hold clues to the lives of people who endured this perilous journey.

In 1997 the shipwreck was identified off the coast of Biloxi, Mississippi, by marine archaeologists with the Department of the Interior's Minerals Management Service (MMS). Research conducted on this important shipwreck has also identified clues about the merchant shipping industry, and the development of IRON-HULLED steamship technology of the nineteenth century.

NOTE TO TEACHERS

This Teacher's Resource accompanies the Minerals Management Service's (MMS) educational poster "Historic Shipwrecks of the Gulf of Mexico." The resource is an introduction to the sidewheel steamship *Josephine* as an example of the types of shipwrecks found in the Gulf of Mexico. The resource is not meant to include everything about marine archaeology and we recommend that teachers use other resources to expand on this introduction. The materials presented can be adapted to levels 7-12.

ABOUT THIS UNIT

This unit is based on the National Register of Historic Places registration file "Josephine" and other sources on sidewheel steamships of the nineteenth century. It was written by Dave Ball, marine archaeologist with the U.S. Department of the Interior's Minerals Management Service, Gulf of Mexico Region, New Orleans, Louisiana. This unit was reviewed by Leina Ball and Adam Rowe, junior high school teachers in the St. Tammany Parish School District, Mandeville, Louisiana.

Where It Fits into the Curriculum

Topics: This lesson could be used in units on commerce, maritime transportation, or technology. It can be used to help students learn about the maritime industry along the Gulf Coast of the United States in the nineteenth century or to understand the importance of merchant steamships in the settlement of the Texas Gulf Coast.

Period: Mid-nineteenth century

Standards: This lesson complies with standards set forth by the National Council for the Social Studies. In particular, it falls within the following themes:

- II. Time, Continuity, and Change;
- III. People, Places, and Environment;
- VII. Production, Distribution, and Consumption;
- VIII. Science, Technology, and Society.

Objectives for Students

- 1) To understand the importance that maritime transportation had on the settlement and development of the Gulf Coast.
- 2) To examine the significance of historic shipwrecks in understanding the past.
- 3) To learn how historical documents and photos can assist researchers in learning more about historic events.
- 4) To gain skills in drawing conclusions on the basis of map analysis, readings, and visual exercises.

Materials for Students

The materials listed below either can be used directly on the computer or can be printed out, photocopied, and distributed to students. The maps and images appear twice: in a low-resolution version with associated questions and alone in a larger, high-resolution version.

- 1) One map of steamship routes along the Gulf Coast and the current location of the vessel.
- 2) Three readings on the importance of steamship commerce along the Gulf of Mexico in the mid-nineteenth century; the sinking of the vessel; and Charles Morgan, the owner of the steamship *Josephine*.
- 3) One SIDESCAN-SONAR image and one site map of the shipwreck for comparison.
- 4) Three photos and a sketch of the steamship Josephine.
- 5) One list of vocabulary terms (words appearing in SMALL CAPS within the text are defined here).
- 6) One list of supplemental resources.

Visiting the Site

Because of the nature of this particular site, it is rather difficult to visit. However, it is not impossible. The remains of the vessel lie in about 35 feet of water, approximately 6 miles south of Ship Island and Horn Island. Visitors must be certified SCUBA divers and would need to have access to a boat to take them to the site.

SETTING THE STAGE


Explain to students that the steamship *Josephine* played a critical role in the development of merchant shipping along the Gulf Coast. Before the advent of cars, airplanes, and gaspowered engines, steamships were one of the most dependable and commonly used methods of transporting passengers and cargo over long distances. With the development of IRON-HULL steamships in the mid-nineteenth century, the merchant shipping industry grew and regular routes were established to areas that had previously been difficult to reach. Situated near the mouth of the Mississippi River, the city of New Orleans held a unique position that allowed it to become the largest port city in the southern United States. Goods from the interior U.S. were brought downriver and loaded onto ocean-going vessels for transport to markets elsewhere along the U.S. coast, or to foreign markets such as those in Europe. Likewise, foreign merchandise was transferred from ocean-going ships at New Orleans to riverboats and then carried upstream to reach towns in the interior U.S.

One of the most influential men involved in the Gulf Coast STEAMBOAT industry was Charles Morgan, who developed interests in merchant shipping in the 1830s. During his career, Morgan established the first regular steamship route between New York and Charleston, South Carolina. He started the first steamship business in Texas, which brought the first steamship to the Gulf of Mexico. He had ties to the Pacific merchant steamship trade and also had interests in merchant shipping in Central America and Mexico. Morgan's influence can still be seen in the southern U.S. today. For example, Brashear City, Louisiana, was renamed Morgan City after he established a regular steamship route between this city and Galveston, Texas. The Morgan steamship *Josephine* was the first vessel to operate along that route.

By conducting historical research, as well as recording and analyzing the current remains of the *Josephine*, we can learn more about this vessel and the impact it had on the merchant steamship trade along the U.S. Gulf Coast in the mid-nineteenth century.

LOCATING THE SITE

During the middle of the nineteenth century, the major transportation routes along the southern states were often over water. The map below shows the major water routes discussed in the following pages; shown also are the approximate locations of the shipwrecks *Mary*, *New York*, and *Josephine*.

Exercises for Map 1

- 1. Review the locations of each of the cities on the map and trace the major steamship routes along the Gulf Coast of the United States.
- 2. Locate the two major routes of the steamship *Josephine:* Morgan City to Galveston; New Orleans to Havana.
- 3. Review the locations of the three shipwrecks on the map.
- 4. Why do you think the routes above paralleled the coastline rather than heading straight across the Gulf?
- 5. Why do you think New Orleans, instead of Morgan City or Mobile, developed into one of the major port cities of the United States?

DETERMINING THE FACTS: READINGS

READING 1: HISTORY OF THE STEAMSHIP JOSEPHINE

In 1867, New York businessman Charles Morgan contracted the Harlan and Hollingsworth Company of Wilmington, Delaware, to construct the IRON-HULL sidewheel steamer *Josephine*. Completed in early 1868, the vessel first arrived at New Orleans, Louisiana, on February 29, 1868, having departed from Wilmington on February 6. Along the way, *Josephine* made stops in Havana, Cuba, and Key West, Florida.

Josephine was designed for use along the U.S. Gulf Coast, and incorporated design features similar to most of the sidewheel steamers that were constructed along the Atlantic Coast during the middle 1800s. The ship had a round STERN, two cabins, two decks, two masts, and could transport up to 250 passengers. While no construction plans have been identified for this vessel, she was registered at 1,282.53 tons, 235 feet long, 34 feet wide, with an 18.5-foot depth of hold. Though she operated primarily between New Orleans, Louisiana, and Galveston, Texas, Josephine FOUNDERED in a storm in 1881 while enroute to New Orleans from Havana, Cuba.

Among the passengers on her maiden voyage were the vessel's owner, Charles Morgan, and several members of his family. A newspaper report from that time described the vessel as "...the most beautiful and elegant of any that have entered the port of Havana" (*Daily Picayune* 1868).

The *Josephine*'s arrival in the Crescent City (New Orleans) coincided with the implementation of a regular route between Brashear City (later renamed Morgan City in honor of Charles Morgan), Louisiana, and Galveston, Texas. During her service, from 1868 to 1881, the *Josephine* made 2-3 trips per week between these ports. Additional vessels also serviced this route. As with many of the regularly established routes, the U.S. mail became a standard cargo on these vessels, allowing for regular communication between the New Orleans and Galveston areas.

Josephine played a critical role in the development of merchant shipping along the Gulf Coast. As regular routes were established, harbor improvements were made, which contributed to the growth of these areas. As a result, people and businesses began to settle near these locations in order to take advantage of the newly established transportation.

Not long after *Josephine* began regular service she was almost lost when she ran aground off the Texas coast. After about two weeks the steamer was refloated, taken back to New Orleans, and placed in dry dock at the Vallette Dry Dock facility in Algiers, where she was inspected for leaks. Inspection was unable to identify any major damage, and the vessel was soon returned to service.

For the most part, *Josephine's* service along the Gulf Coast was uneventful. In March 1875, however, the ship played a role in Texas history by serving as a refuge for the citizens of

Corpus Christi when Mexican bandits attacked the town. When it was learned that an assault was imminent, residents boarded *Josephine* and waited it out safely offshore.

Early in 1881, *Josephine* was transferred to the New Orleans, Louisiana, to Havana, Cuba, route, replacing the steamer *Morgan*, another vessel built by the Harlan and Hollingsworth Company and operated by Charles Morgan. This was to be *Josephine*'s last voyage.

On January 27, *Josephine* left New Orleans, and arrived in Havana a few days later. On February 2 she departed Havana with several passengers and a cargo of tobacco and cigars. Among the passengers was a family of musicians led by Professor Herman Franko. According to Professor Franko's account of the FOUNDERING, the steamer began her return trip to New Orleans at 5 p.m. on February 2. She arrived in Key West the following afternoon and departed for Cedar Key that evening, arriving on the morning of Friday the fourth. At Cedar Key, the *Josephine* picked up several more passengers. Included among the new passengers were 14 members of an Italian crew that had recently survived the sinking of their lumber ship, originally bound for London from Pensacola.

Josephine left Cedar Key around 4 p.m. Friday, February 4, 1881, en route to New Orleans, and sailed without incident until sometime Sunday, when one of the crewmembers noticed that the vessel was leaking. Passengers and crew worked frantically to bail water but could not control the leak, so arrangements were made to abandon the ship. Prior to the captain giving the order, however, the leak began to subside. Yet not long after, the seas picked up and *Josephine* began to take on water once more. On Monday evening the captain again had the crew prepare to abandon ship. By 3 a.m. Tuesday morning all had escaped, and the vessel began to heel to one side. Though all of the approximately 65 passengers and crew escaped the sinking, the captain's dog was not so lucky.

A second account, from an unidentified passenger, said *Josephine* ran into a hurricane sometime Saturday afternoon, which did not let up until Monday. "On Sunday morning it was discovered that the pressure of the water against the side of the ship opened the seams and the water was pouring in at a fearful rate." This incident was reported as the first serious accident to a Morgan Line vessel in 11 years. The loss of *Josephine* was valued at \$75,000.

Though it was described as a hurricane by one of the survivors, the time of the FOUNDERING was in early February, well after hurricane season ends on the Gulf Coast. Nevertheless, it must have been a very severe winter storm, for several accounts of storm damage were detailed in the February 10, 1881, edition of the New Orleans *Daily Picayune*. Included in the reports was an account that most of the buildings at Pass Manchac were destroyed. Damage was also incurred at least as far east as Pensacola, Florida.

Discovery of the Josephine

Today the shipwreck lies in about 38 feet of water between Horn Island and Ship Island, two of the barrier islands in the Chandeleur chain off Mississippi. Divers from the Department of the Interior's Minerals Management Service carried out investigations on this wreck during the summers of 1997 and 1999. These investigations were limited to just a few days, with the primary purpose of photodocumenting the site. The investigations also aimed to collect as much information as possible to confirm the identification of the vessel by using noninvasive techniques.

At present, much of the iron hull of the wreck is buried but appears to be mostly intact from the KEEL to the WATERLINE. The upper hull above the WATERLINE is gone. The BOW of the ship is completely buried, but the line of the hull may be followed with only short interruptions to the vessel's RUDDER.

One of the most dramatic features of the wreck is the WALKING BEAM engine, the diamondshaped feature that connected the engine piston to the ECCENTRIC of the PADDLEWHEELS, which lies collapsed against the STARBOARD side of the ship. The WALKING BEAM engine was built by the Morgan Iron Works Company of New York City. This company was also owned by Charles Morgan.

- 1. What was one of the regular cargoes carried on the Josephine?
- 2. Approximately how many days did it take to travel from New Orleans to Havana?
- 3. Why do you think the *Josephine* sailed along the route it did?
- 4. Pretend you are a crew member that survived the sinking of the *Josephine*. Write an account of what happened for the daily newspaper.
- 5. What impacts do you think the loss of *Josephine* had on the people of New Orleans and Havana?

READING 2: WHO WAS CHARLES MORGAN?

One of the foremost figures in the development of the steamship trade along the Gulf Coast of the United States was not a Southerner at all, but a New York businessman named Charles Morgan. Morgan was born in Killingsworth, Connecticut, on April 21, 1795. At the tender age of 14, young Charles traveled to New York City to take a position as a grocery clerk. Opportunities abounded for ambitious young men in the bustling port of New York and by age 20 Morgan was proprietor of a ship CHANDLERY and soon thereafter began importing goods from the southern United States and the West Indies.

Charles Morgan developed interests in merchant shipping in the 1830s and achieved success numerous times. As part owner of the New York and Charleston Steam Packet Company, he established the first regular steamship route between these two cities in 1834. Shortly thereafter, he bought out the other partners and established the Southern Steam Packet Company. This company prospered under his direction and acquired government contracts to transport U.S. troops and supplies to Florida during the Florida Indian Wars. The company also secured a contract to transport the U.S. mail between New York and Charleston.

In 1837, Charles Morgan expanded his interests to the Gulf Coast. Though he lost about 10 ships in the process, he established the first regular steamship service in Texas in the late 1830s. Around this time Morgan also had ties to the Pacific merchant steamship trade and merchant shipping in Central America and Mexico.

As with all of Morgan's steamship companies, one of the regular cargoes shipped on the Gulf Coast line was the U.S. mail. By 1855, Morgan's Southern Steamship Company established routes between New Orleans, Galveston, and Port Lavaca, and by 1860 Morgan was operating six regular routes in the Gulf.

In addition to his vast steamship interests, Morgan also developed a lucrative ironworks company. The Morgan Iron Works company, located in New York City, became one of the leading producers of marine steam engines in the United States in the mid-nineteenth century. The company provided steam engines for many of the Atlantic COASTAL STEAMERS. It also equipped most of the ships employed by Morgan, as well as many of the American-owned steamships operating in China. At its peak, the company employed over 1,000 men.

During the Civil War, the Morgan Iron Works supplied machinery for several Union naval vessels and also constructed the Union Monitor-class IRONCLAD *Onondaga*. After most of his Gulf Coast ships were commandeered by the Confederate Navy, the Southern Steamship Company ceased operations in 1863. A few of his remaining Gulf Coast steamers, however, operated as BLOCKADE RUNNERS during the war. Always one to profit from opportunity, Morgan arranged for the construction of five new vessels at the Harlan and Hollingsworth shipbuilding facilities in Wilmington, Delaware, between 1862 and 1864. These ships operated as Union charter vessels. After the Civil War, Morgan's interests returned to the Gulf of Mexico and within four years had surpassed his pre-war holdings.

Morgan's greatest goal after the Civil War was to develop a unified system of steamship and railroad lines that would connect the Gulf southwest with the Mississippi Valley, northern Latin America, and the Atlantic and Pacific coasts. Between 1877 and 1885, Morgan realized much of his dream. The initial step was taken by the newly elected Democratic legislature of 1877, which chartered Morgan's Louisiana and Texas Railroad and Steamship Company (M.L. & T.R. & S.), giving him the widest possible latitude to extend rail lines throughout Louisiana and Texas, to connect to existing lines, and to own and operate his ships.

Charles Morgan died at the age of 83 in 1878, at the zenith of his company's power and influence. The M.L. & T.R. & S. lived on briefly in the capable hands of Morgan's son-inlaw and heir, Charles Whitney, until his death in 1882. Between the death of Charles Whitney and the railroad consolidation movement of the 1880s, the Morgan Line ceased to exist as a family enterprise by 1885. The mark that it left on the economic history of the Gulf South and on the United States was indelible. During the span of Morgan's lifetime, the public had come to take the existence of regular, long-distance transportation for granted, and national and state governments undertook projects that had been left to private initiative. In other words, the modern mixed economy evolved as a result of achievements of men such as Charles Morgan.

Remains of an Empire

Of the 117 steamships owned by Charles Morgan or his corporate enterprises between 1833 and 1885, the wrecks of three have been discovered in the Gulf of Mexico or contiguous waters. One of these, *Mary*, was recorded by archaeologists off Aransas Pass, Texas, in 1995. The U.S. Department of the Interior's Minerals Management Service (MMS) has documented two others, *New York* and *Josephine*. Taken together, these vessels represent the span of steamships employed by the Morgan Line and document the changing technology of steam navigation in the United States.

Questions for Reading 2

- 1. When did Charles Morgan begin operating merchant steamships?
- 2. How many of Morgan's ships have been found by archaeologists? What are their names?
- 3. What was one of the primary cargoes transported on all of Morgan's steamships? Why do you think this was such a popular way to transport this cargo?
- 4. Did Charles Morgan work with the Union, the Confederacy, or both sides during the Civil War? Why?
- 5. Explain the importance of establishing regular transportation routes along the Gulf Coast. What effect would regular steamship transportation have on people living near these routes?

READING 3: PADDLEWHEEL STEAMBOATS

By the beginning of the nineteenth century, several cities located along the coast and at the mouths of major waterways in the United States had already been established as centers for maritime trade and commerce. Cities like New York, Boston, and New Orleans served as hubs to move products and people from the interior to places elsewhere. Regular maritime shipping routes had also been established between coastal communities of the U.S. as well as with major markets overseas (primarily in Europe). People from the interior used the major river systems to transport their goods to these coastal port cities where they could be loaded on large oceangoing vessels for further transport to other markets. in return, the large oceangoing vessels brought goods from other markets to the coastal ports, where they were off-loaded and then shipped upriver to the smaller communities of the interior.

Though the routes these sailing vessels traveled had long been established, their reliability to arrive on a particular day was extremely variable. While riverboats could rely on both wind and current to carry them downstream, the oceangoing vessels were dependent primarily on sail power. If there was no wind to carry a vessel, it could cause serious delays, sometimes up to several weeks.

In the early 1800s, STEAMBOAT technology began to take off in the United States. the idea of harnessing the energy produced from steam was not new, but STEAMBOAT technology was not readily accepted until Robert Fulton successfully completed construction of the *Clermont*, the first STEAMBOAT built in the United States. After its trial run from New York to Albany in 1807, a regular route was established and the *Clermont* became the first steam-powered PACKET-BOAT. the reason the *Clermont* was so successful was because she was able reliably to make the round trip voyage from New York to Albany to New York, a distance of approximately 250 miles, in about 62 hours. Though this seems rather long by today's standards (for instance, a car on the highway can travel this distance in about 4 hours), sailboats could take several days to complete a journey of this distance.

In December 1811, the first STEAMBOAT began its way down the Ohio and Mississippi Rivers, from Pittsburgh, Pennsylvania, to New Orleans, Louisiana. This was the sternwheel steamer *New Orleans*, owned by Nicholas J. Roosevelt. It arrived at the city of New Orleans on January 12, 1812, taking 14 days to complete this voyage. Once it was shown that steamboats could reliably travel great distances on the navigable waterways of the United States, they became the preferred method of transporting passengers and cargo. Major waterways of the United States, such as the Missouri, the Ohio, and the Mississippi Rivers, as well as the Great Lakes, and the coastlines of the Atlantic, Pacific, and Gulf of Mexico became the primary transportation routes of the nineteenth century.

Steamboats had many advantages over sailboats. Since steamboats were not dependent upon the wind to move them, they could travel nonstop as long as the engine was operational. With the ability to operate regularly and faster than sailboats, STEAMBOAT owners could schedule frequent and dependable arrival and departure times which, in turn, encouraged the development of such things as tourism, transshipment of fresh produce, and the expansion of settlement into frontier areas. Further, since all of the early steamboats were propelled by large PADDLEWHEELS, they could maneuver in much shallower water. As more steamboats were constructed and more routes established, maritime commerce increased. As new routes were developed, STEAMBOAT owners would often work closely with local businesses to develop facilities to improve maritime trade. Improvements were often made to facilities such as harbors and wharves, and once the area began to grow, more warehouses were built to handle the rise of import and export commerce.

Another key component of regular STEAMBOAT routes was the transport of the U.S. mail. Since the inland and coastal waterways were the most efficient means of travel, many steamboats were contracted to carry the mail between port cities. The reliability of regular mail service and supplies, as well as improvements to infrastructure, made these port cities more desirable to people, and resulted in population increases in these cities as well.

The heyday of the PADDLEWHEELERS came after the end of the American Civil War. During the 1870s and 1880s, people came to rely on steamboats to take them between cities and to transport freight. However, by the early twentieth century, steamboats were phased out as new ship technology was developed. Today, PADDLEWHEEL steamboats are used primarily for tourism, as a way to allow people to experience what 19th-century river life was like.

- 2. Who was responsible for bringing the first steamboat down the Mississippi River to the city of New Orleans?
- 3. Describe some of the reasons why steamboats were more efficient than sailboats.
- 4. Describe how steamboats influenced the development of port cities.
- 5. You are a steamboat captain. Describe a recent trip you've made from New Orleans to Galveston. Explain the type of cargo and passengers you have on board. How long does your voyage take and what type hazards might you encounter on this journey?
- 6. Before electricity, how do you think perishable cargo might have been preserved during a typical steamboat voyage?

VISUAL EVIDENCE

EXERCISE 1: MAPPING THE SHIPWRECK JOSEPHINE

The sketch map below (Figure A) was made from information gathered by scientific divers working for the Minerals Management Service in 1999. Additional information was obtained by analyzing data obtained through a SIDESCAN-SONAR survey of the shipwreck (Figure B). A SIDESCAN-SONAR operates by sending out an acoustic signal from a sensor (towfish) that is towed by a survey boat. The signal is sent from both sides of the sensor to the seafloor, then the signal returns to the sensor, giving a visual image of the bottom surface.




Figure A. Sketch map of the sidewheel steamship Josephine (site number 22HR843).




Figure B. Sidescan-sonar image of the Josephine.

Questions for Figures A and B

- 1. Compare the two figures and locate the outline of the hull in Figure B.
- 2. How can you tell the image in Figure B is a shipwreck?
- 3. Using the map in Figure A, what features can you identify in Figure B?

- 4. Why do you think the hull line in the two figures is not continuous?
- 5. How might commercial fishing activities (eg., shrimp trawling) affect a shipwreck like *Josephine*?
- 6. If you were a marine archaeologist, what do you think you might learn about the past from studying this shipwreck?

EXERCISE 2: WALKING BEAM ENGINE

The two figures below depict part of the WALKING BEAM engine that was used on the *Josephine* and many other steamships. The WALKING BEAM was a specific type of steam engine developed for steamboats in the United States around 1830. As Figure A shows, the diamond-shaped beam sits atop an A-FRAME structure and is connected to rods at either end. One of these rods causes the crankshaft to move which, in turn, causes the PADDLEWHEEL to rotate, propelling the ship through the water.

This type of engine was used primarily for river steamboats but was also found occasionally on oceangoing vessels. The drawing (Figure A) comes from an historical sketch of the WALKING BEAM engine that was used to power Charles Morgan's steamship *Arizona*, which was built in 1858. The photo (Figure B) was taken by scientific divers from the Minerals Management Service during their investigation of the shipwreck in 1999. Note the similarity of the diamond-shaped beam at the top of Figure A to the feature in Figure B.




Figure A. Historical sketch of walking beam (courtesy of the Mariner's Museum, Newport News, VA).

Questions for Figures A and B

- 1) Locate the diamond-shaped walking beam and the A-FRAME structure in Figure A. How does it compare to the picture in Figure B?
- 2) Which of the following (the mast, the PADDLEWHEELS, or the BOW) would you expect to find near the walking beam engine? Why?
- 3) How do you think the top figure (Figure A) can help archaeologists piece together the puzzle to document features like the location of the walking beam engine (Figure B)?

EXERCISE 3: PHOTO DOCUMENTATION

Below are two historical photos of the steamship *Josephine*. The first photo (Figure A) shows the vessel in operation, perhaps near New Orleans. The second photo (Figure B) shows the ship in dry dock, possibly after it ran aground off the coast of Texas (see Reading 1).




Figure A. Historical photo of *Josephine*, note walking beam (photo courtesy of the Mariner's Museum, Newport News, VA).




Figure B. Historical photo of *Josephine* in dry dock (photo courtesy of the Mariner's Museum, Newport News, VA).

Questions for Figures A and B

- 1) Locate the walking beam engine in the photos above.
- 2) Compare the photos above with the images in "Exercise 1: Mapping the Shipwreck *Josephine.*" How do you think photos like these can help archaeologists document the current condition of the shipwreck?
- 3) What information can you infer about the construction of the ship on the basis of these photos (that is, how many decks, how many masts, how many PADDLEWHEELS, etc.)?

PUTTING IT ALL TOGETHER

ACTIVITY 1: CREATE A PADDLEWHEEL

This activity is designed to give students a basic understanding of how a PADDLEWHEEL works. Students will construct a PADDLEWHEEL from the material listed below. After the activity is completed, explain to the students that the PADDLEWHEEL operates by using potential energy to create kinetic energy. When the rubber band is wound, it stores energy (potential energy) until the PADDLEWHEEL is released. As it unwinds, it causes the PADDLEWHEEL to turn, pushing water away from the bottle (kinetic energy), and forcing the bottle forward. This exercise was adapted from the book *Water, Paddles, and Boats* by Pam Robson (Aladdin Books, 1992).


Materials:

- 1. A small plastic bottle with a top.
- 2. A rubber band.
- 3. Two sticks (or pencils), approximately 6 inches long.
- 4. One small cardboard juice or milk carton.
- 5. Tape and scissors.
- 6. An empty cardboard papertowel roll.
- 7. A sink or tub filled with water.

Assembly:

- 1. With the bottle on its side, tape the two sticks to either side of the bottle so that at least two inches of the stick lengths extend past the bottom of the bottle.
- 2. Cut two rectangular pieces from the cardboard carton, make sure the pieces are smaller than the base of the plastic bottle.
- 3. Cut a slit halfway down the middle of each rectangular piece, lengthwise. Slide these two pieces together to make the paddlewheel.
- 4. Place the paddlewheel between the two sticks at the base of the bottle and loop the rubber band around each stick. Be sure the paddlewheel does not touch the bottle or the sticks.
- 5. Fill the bottle with enough water so that the paddlewheel will be partially submersed.
- 6. Cut a one to two-inch piece from the papertowel roll and tape this to the top of the bottle as shown in the figures below.
- 7. Now wind the rubber band, place the boat in water and let it go.

8. Have the students conduct different experiments with the paddlewheel. Does the boat travel farther if the rubber band is wound tighter? What happens if you wind the rubber band the opposite way? What happens if you use rubber bands of different sizes? Does the amount of water in the bottle affect the movement of the boat?



ACTIVITY 2: LOCAL SHIPWRECKS

This activity is designed to give students a sense of the importance of underwater archaeology in their community. Over the past 20 years, historic shipwrecks have been discovered in most of the major waterways of the United States. Have the students conduct an Internet search or conduct research in their local library for underwater archaeological sites in their area (there are a few Internet sites listed in the "Supplementary Resources" section). See if the students can identify any shipwrecks that may have been associated with transporting people or merchandise to their area. Ask them to describe what impact this shipwreck had on their community. See if the students can determine how archaeologists are able to learn more about the history of their community by studying the remains of ships that wrecked more than 50 years ago.

VOCABULARY

- A-FRAME: A support structure that consists of two legs that come together at the top, resembling the letter A.
- BLOCKADE RUNNER: A vessel used to transit through or around a naval blockade (a blockade consists of a group of patrol ships designed to prevent other ships from departing or entering an enemy port).
- BOW: The front end of a boat or ship.
- CHANDLERY: A supply house for materials used on ships.
- COASTAL STEAMER: A steamship built to operate in the open-water areas along the coast.
- ECCENTRIC: On a steamship, the part of the crankshaft that creates a reciprocating motion.
- FOUNDER: The sinking of a ship at sea, usually caused by flooding of some sort.
- IRONCLAD: A wooden vessel that has a layer of iron placed on the outside of the hull to provide protection from enemy gunfire.
- IRON-HULL: The material used to construct the hull of a vessel. The use of iron for hull construction did not begin until the middle nineteenth century, with the advent of the industrial revolution.
- KEEL: Often referred to as the backbone of the ship. This is the principal timber that runs the length of the vessel and is often the first timber placed in construction.
- PACKET (PACKET-BOAT): A vessel that operated on a regular route carrying mail, passengers, and other cargo.
- PADDLEWHEEL: A wheel fitted with a series of paddles, blades, or floats used to propel a vessel through the water. Paddlewheel propulsion is found on steamships and can be in the form of either a sternwheeler (where the paddlewheel is mounted on the back of the vessel), a centerwheeler (where the paddlewheel is mounted across the center of the vessel), or a sidewheeler (where the vessel is propelled by two paddlewheels located near the center on either side of the vessel). Typically, paddlewheel ships can navigate in shallower water than vessels propelled by other means.
- RUDDER: A steering mechanism located at the STERN of a ship.
- SIDESCAN SONAR: A remote-sensing device that operates with an acoustic sensor. This instrument consists of three components: a processor (computer), a sensor (towfish), and a cable. An acoustic signal is sent down and away from the sensor toward the seafloor. When the signal bounces off the seafloor and returns to the sensor, the signal is then processed by the computer to give a visual image of the bottom.
- STARBOARD: The right side of a vessel. The word developed from an old English term "steer-board." This referred to the use of a board or RUDDER ("steor") that was used on the back right side of boats for steering.
- STEAMBOAT (STEAMSHIP): A vessel that uses steam for power.
- STERN: The back end of a boat or ship.

- WALKING BEAM: A type of steam engine developed for steamboats in the United States around 1830. It was used primarily for river steamboats, but was occasionally found on oceangoing vessels. As Exercise 2, Figure A shows, the diamond-shaped beam sits atop an A-FRAME structure and is connected to rods at either end. One of these rods connects to the ECCENTRIC and causes the crankshaft to move which, in turn, causes the PADDLEWHEEL to rotate, propelling the ship through the water.
- WATERLINE: The line on a ship where the surface of the water is located. A ship's waterline can change according to whether the vessel is loaded or empty.
