

The following quarantined articles require a certificate or permit prior to movement from quarantined area into or through a non-quarantined area:

- 1. Soil, separately or with other things, except soil samples shipped to approved laboratories.* Potting soil is exempt, if commercially prepared, packaged and shipped in original containers.
- 2. Plants with roots with soil attached, except house plants maintained indoors and not for sale.
- Grass sod.
- 4. Baled hay and straw stored in direct contact with soil.**
- 5. Used soil moving equipment.
- 6. Logs, pulpwood and stumps.***
- 7. Any other products, articles, or means of conveyance of any character whatsoever not covered by the above, when it is determined by an inspector that they present a hazard of spread of the imported fire ant and the person in possession thereof has been so notified.
- * Information as to approved laboratories may be obtained from an inspector.
- ** Not eligible for movement outside the quarantined area.
- *** Exemptions from permit requirements apply for treated railroad loading sites.
