Department of Defense Appropriations Act, 2012: The House passed H.R. 2219, making appropriations for the Department of Defense for the fiscal year ending September 30, 2012, by a yea-and-nay vote of 336 yeas to 87 nays, Roll No. 532. Consideration of the measure began on June 23rd.
