**Reports Filed:** Reports were filed today as follows: H.R. 200, to direct the Secretary of the Interior to conduct a study of water resources in the Rialto-Colton Basin in the State of California, and for other purposes (H. Rept. 112–367);

H.R. 2070, to direct the Secretary of the Interior to install in the area of the World War II Memorial in the District of Columbia a suitable plaque or an inscription with the words that President Franklin D. Roosevelt prayed with the nation on June 6, 1944, the morning of D-Day, with an amendment (H. Rept. 112–368);
