**Suspension:** The House agreed to suspend the rules and pass the following measure:

**Ultralight Aircraft Smuggling Prevention Act of 2012:** H.R. 3801, to amend the Tariff Act of 1930 to clarify the definition of aircraft and the offenses penalized under the aviation smuggling provisions under that Act, by a 2/3 yea-and-nay vote of 408 yeas with none voting “nay”, Roll No. 11.

**Suspension—Proceedings Resumed:** The House agreed to suspend the rules and pass the following measure which was debated yesterday, January 24th:

**Buffalo Soldiers in the National Parks Study Act:** H.R. 1022, to authorize the Secretary of the Interior to conduct a study of alternatives for commemorating and interpreting the role of the Buffalo Soldiers in the early years of the National Parks, by a 2/3 yea-and-nay vote of 338 yeas to 70 nays, Roll No. 10. **Pages H166–67**

**United States-China Economic and Security Review Commission—Appointment:** The Chair announced the Speaker’s appointment of the following member on the part of the House to the United States-China Economic and Security Review Commission for a term to expire December 31, 2013: Mr. Daniel M. Slane of Ohio. **Page H169**
