Suspension—Failed: The House failed to agree to suspend the rules and pass the following measure that was debated yesterday, May 30th:

Prenatal Nondiscrimination Act (PRENDA) of 2012: H.R. 3541, amended, to prohibit discrimination against the unborn on the basis of sex or race, by a <sup>2</sup>/<sub>3</sub> yea-and-nay vote of 246 yeas to 168 nays, Roll No. 299.

Intelligence Authorization Act for Fiscal Year 2013: The House passed H.R. 5743, to authorize appropriations for fiscal year 2013 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System, by a recorded vote of 386 ayes to 28 noes, Roll No. 301.
