NUMBER 7770.03 December 5, 2011

SUBJECT: Reporting Requirements for Reserve Components Military Pay File Extracts (RCMPFE)

References: See Enclosure 1

1. <u>PURPOSE</u>. This Instruction reissues DoD Instruction (DoDI) 7770.03 (Reference (a)), in accordance with the authority in DoD Directive (DoDD) 5124.02 (Reference (b)), to establish policy, assign responsibilities, prescribe procedures, and establish requirements for the reporting of Reserve Component (RC) pay data.

2. <u>APPLICABILITY</u>. This Instruction applies to:

a. OSD, the Military Departments (including the Coast Guard at all times, including when it is a service in the Department of Homeland Security by agreement with that Department), the Office of the Chairman of the Joint Chiefs of Staff and the Joint Staff, the Combatant Commands, the Office of Inspector General of the Department of Defense, the Defense Agencies, the DoD Field Activities, and all other organizational entities within the DoD.

b. All officers, warrant officers, and enlisted personnel assigned to the Ready, Standby, and Retired Reserve.

c. Reserve Officer Training Corps (ROTC) cadets and midshipmen receiving a form of Federal financial support such as tuition, subsistence, summer training stipend, expenses, or uniform allowance.

3. DEFINITIONS. See Glossary.

4. <u>POLICY</u>. It is DoD policy that:

a. The DoD shall maintain a centralized capability for the timely reporting of the pays, allowances, deductions and collections of RC military Service members pay data for interagency reporting, research, actuarial purposes, and evaluation of DoD programs and policies.

b. The Privacy Act requirements and procedures prescribed by DoD 5400.11-R (Reference (c)) must be followed to safeguard personal data contained in this reporting system.

5. <u>RESPONSIBILITIES</u>. See Enclosure 2.

6. <u>PROCEDURES</u>. See Enclosure 3.

7. <u>INFORMATION REQUIREMENTS</u>. The report prescribed in Enclosure 4 is assigned Report Control Symbol DD-RA(M)1851 in accordance with DoD Manual (DoDM) 8910.1-M (Reference (d)).

8. <u>RELEASABILITY</u>. UNLIMITED. This Instruction is approved for public release and is available on the Internet from the DoD Issuances Website at http://www.dtic.mil/whs/directives.

9. <u>EFFECTIVE DATE</u>. This Instruction is effective upon its publication to the DoD Issuances Website.

#### **RESPONSIBILITIES**

#### 1. <u>UNDER SECRETARY OF DEFENSE FOR PERSONNEL AND READINESS</u> (<u>USD(P&R)</u>). The USD(P&R) shall:

a. Develop policies, plans, and programs for total force personnel to require efficient and effective support of wartime and peacetime operations, contingency planning, and preparedness.

b. Exercise such policy guidance and management supervision for the Defense Manpower Data Center (DMDC), through the DoD Human Resources Activity (DoDHRA) consistent with the responsibilities in Reference (b), to require adequate resources are available and used by the DMDC to fulfill the requirements listed in this Instruction.

2. <u>ASSISTANT SECRETARY OF DEFENSE FOR RESERVE AFFAIRS (ASD(RA))</u>. The ASD(RA), under the authority, direction, and control of the USD(P&R) and consistent with DoDD 5125.01 (Reference (e)), shall provide guidance, requirements, and procedures for the DoD reporting of RC military pay, allowances, deductions, and collections pay data.

3. <u>DIRECTOR, DoDHRA</u>. The Director, DoDHRA, under the authority, direction, and control of the USD(P&R), shall ensure that the Director, DMDC:

a. Follow the requirements prescribed by DoDDs 5400.11 and 5015.2 (References (f) and (g)) to safeguard data contained in this reporting requirement and oversee that the RCMPFE is an approved records schedule.

b. Operate and maintain the RC military pay files, to include computer support, software development, quality control, inquiry capability, and administrative support.

c. Develop, produce, and distribute all periodic and ad-hoc RCMPFE reports.

d. Provide record-level data, programming, reports, and analytical support, as requested, to the ASD(RA) for special studies requiring use of the RCMPFE.

e. Inform the ASD(RA) of data produced from the RCMPFE for other users as well as the quality level of the RC pay information, provided by the Defense Finance Accounting Service (DFAS), U.S. Marine Corps, and U.S. Coast Guard pay sites as submitted by the RCs.

#### 4. <u>UNDER SECRETARY OF DEFENSE (COMPTROLLER) (USD(C))/CHIEF FINANCIAL</u> OFFICER (CFO), DEPARTMENT OF DEFENSE. The USD(C)/CFO shall

a. Establish DoD policy and provide information and compliance guidance for the administration of military pay.

b. Exercise authority, direction, and control over the Director, DFAS, in matters pertaining to the operations and functions of the DFAS in accordance with DoDD 5118.03 and Volume 7A of DoD 7000.14-R (References (h) and (i)).

5. <u>DIRECTOR, DFAS</u>. The Director, DFAS, under the authority, direction, and control of USD(C)/CFO, shall provide timely and accurate submissions of military pay extract files to the DMDC pursuant to DoD policies and this Instruction.

6. <u>SECRETARIES OF THE MILITARY DEPARTMENTS AND COMMANDANT, U.S.</u> <u>COAST GUARD</u>. The Secretaries of the Military Departments and the Commandant, U.S. Coast Guard, working with their respective pay site, shall implement this Instruction.

#### PROCEDURES

#### 1. GENERAL GUIDANCE

a. This Instruction establishes requirements and provides guidance in order to collect and report the pays, allowances, deductions, and collections of the pay data of RC Service members, pertaining to those data elements that are available on existing Military Services automated information processing systems.

b. Reporting shall follow the data field sequence in accordance with the Master File coding instructions specified in Enclosure 4.

c. Each report will be accompanied by an e-mail message that identifies the files transmitted and states the number of records in each file(s).

d. Use data elements standardized in accordance with Reference (d), DoDD 8320.02, and "DoD Discovery Metadata Specification Registry" (References (j) and (k)).

#### 2. SUBMISSION AND REPORT INSTRUCTIONS

a. <u>Submission Requirements</u>. Data shall be submitted to the DMDC via secure electronic transmission in compliance with the requirements of this Instruction. DMDC will review and publish submission requirements, file processing procedures, and report instructions that each RC pay site shall use when preparing and sending submissions.

#### b. Reporting Requirements

(1) Each pay site shall submit its data file by Service within 5 calendar days of each month's end ("as-of" date of the file).

(2) Each Service's Reserve Master File shall contain one record for each RC Service member who was paid by Reserve payroll, or discharged, separated, or retired from the RC during the preceding 3 months, as of the reporting date. For a Service that accounts for an RC Service member on active duty (AD) in an AD pay system, report an additional record for each Service member who is a member of the RC and was paid by its AD payroll, as of the reporting date.

#### c. Data Specifications

(1) Order each file by Personal Social Security Number (Record Field 2), in ascending order.

(2) Numeric data, other than dollar amounts, shall be right justified with leading zeros.

(3) Character data shall be left justified with trailing blanks.

(4) Character fields required to report as not applicable ("W") or unknown ("Z") shall be filled with the specified variable for the entire length of the record field. Numeric data required to report as not applicable ("6") or unknown ("9") shall be filled with the specified variable for the entire length of the record field.

(5) All date values shall be reported as YYYYMMDD unless otherwise instructed in the data element description.

(6) All dollar amount fields for pays, allowances, deductions, and collections shall be signed with dollars and cents symbols, with implied decimal and leading zeros, unless otherwise specified. Enter a minus sign (-) sign in the left-most position for negative values and a blank space in the left-most position for zero or positive values. For example, the proper definition for 9-byte amount field in the Common Oriented Business Object Language or Programming Language One would be PIC -999999V99 or PIC -9(6)v99. If the amount field is not applicable, enter zeros.

(7) Fields identified as 'filler' shall be filled with no data at all.

d. File Naming Conventions

(1) Data set names shall be established as generational data sets that will sequentially number when they arrive at the DMDC. The file or data set naming convention of the RC Service member pay data from the Services' RC pay system shall be designated as in Figure 1.

(2) Data set names shall be established as generational data sets that will sequentially number when they arrive at the DMDC. The file or data set naming convention of the RC Service member data from the Service's AD pay system shall employ as in Figure 2.

#### e. Electronic Secure Submission

(1) <u>Data Submission</u>. To electronically submit data to the DMDC, the pay site will contact the Reserve Pay File Manager, who shall require the establishment of an account number and password exclusively for these submissions. They may also provide additional system specifications, including security protocols appropriate to protect the data from compromise and consistent with standards established by the DoDI 8500.2 (Reference (1)).

(2) <u>Transmission of Sensitive Information</u>. The confidentiality level of data being sent to the DMDC, as specified in Enclosures 4, is considered SENSITIVE in accordance with the guidance contained in Reference (1). Sensitive information may be sent via the SECRET Internet Protocol Router Network or, Non-Secure Protocol Router Network (NIPRNET). Sensitive information sent via the NIPRNET must be encrypted prior to transmission. The submitting organization is responsible for the accuracy and completeness of each electronic data transfer.
