## General Permit Requirements

Charter Halibut Permit In addition to other applicable permit and licensing requirements, any charter vessel operator with one or more charter vessel anglers catching and retaining Pacific halibut onboard the charter vessel must have onboard the vessel a valid Charter Halibut Permit or permits endorsed for the regulatory area in which the vessel is operating and endorsed for the number of charter vessel anglers catching and retaining Pacific halibut. This permit is required beginning February 2011.

Area Endorsement A Charter Halibut Permit is valid only in the International Pacific Halibut Commission regulatory area for which it is endorsed. Regulatory areas are defined in the annual management measures published pursuant to regulations at $50 \mathrm{CFR} \S 300.62$.

Charter Vessel Angler Endorsement A Charter Halibut Permit is valid only for the maximum number of charter vessel anglers for which the Charter Halibut Permit is endorsed.
