Nevada is the 37th State to Enact Driver's License Legislation Linked to Registration

On May 22, 2009, Nevada Governor Jim Gibbons signed into law a driver's license legislation that supports Selective Service registration. Effective July 1, 2010, men 18 through 25 renewing or applying for a state driver's license in Nevada will have the option to register with the Selective Service System.

With Nevada, Selective Service has 41 jurisdictions: 37 states, three territories, and the District of Columbia, which have enacted driver's license legislation linked to the federal registration requirement. They are as follows: Alabama, Arizona, Arkansas, Colorado, Delaware, Florida, Georgia, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maryland, Michigan,

Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Mexico, New York, North Carolina, Ohio, Oklahoma, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, West Virginia, Wisconsin, Guam, Northern Mariana Islands, the Virgin Islands, and the District of Columbia.

The bill, sponsored by State Senator Bob Coffin, was introduced on March 13, 2009; passed the state senate on April 13, with 20 yeas, 1 nay and the assembly on May 16, with 40 yeas, 0 nays, and 2 excused votes; and has now been signed by the governor. Selective Service commends everyone involved in bringing participation of Region III Headquarters staff in adding one more state that supports the Selective Service's mission.

Garcia to Serve as Acting Director

As of close of business May 29, 2009, Executive Director Ernest Garcia began serving as Acting Director of the Selective Service System until the Obama Administration selects a full-time Director.

"As a former Executive Director, Deputy Director, Chief of Staff, and Kansas State Director of Selective Service, I now look forward to the opportunity to serve my country as the Acting Director." Garcia said, "I pledge that I will steadfastly steer a course for a successful future for the Selective Service and a more secure America."

Garcia was named Kansas State Director of Selective Service, a part-time position, in July 2001. He joined Selective Service as Chief of Staff in a full-time capacity on April 22, 2005, after a distinguished career in military and public service. He served as an officer in the U.S. Marine Corps Reserve. After being called to active duty in support of Global War on Terrorism in August 2003, Garcia served as an operations officer with the II Marine Corps Expeditionary Forces at Camp Lejeune, NC; Director of Civil Affairs for the Combined Joint Task Force – Haiti; and as a Civil Affairs Officer for the 24th Marine Expeditionary Unit in Iraq. Garcia is also a veteran of Desert Shield and Desert Storm.

Before his return to active duty, Garcia served as senior assistant to the city manager of Witchita, KS. He was previously Chief Executive Officer and member of the Board of Directors of Research and Development Laboratories, a Department of Defense contractor. In 1985, Garcia was nominated by Senate Majority Leader



Bob Dole (R-KS) and confirmed as the 27th Sergeant at Arms of the U.S. Senate. In that capacity, he was the Senate's Chief Operating Officer and Chief Protocol Officer. As the Senate's chief law enforcement officer, Garcia also served as Chairman of the Capital Police Board and member of the

Senate Management Board. Before his Senate experience, Garcia served as Deputy Assistant Secretary of Defense for Legislative Affairs, and as Special Assistant to President Ronald Reagan.

Garcia's military awards include the Defense Meritorious Service Medal, the Navy-Marine Corps Commendation Medal, the Secretary of Defense Medal for Outstanding Public Service, and the U.S. Selective Service System's Distinguished Service Gold Medal.

Born in Garden City, KS, Garcia earned undergraduate and postgraduate degrees in sociology and public administration from the University of Kansas. He also completed Witchita State's University Center for Management Development MBA Program.

Chatfield Completes Tour at Selective Service

William Chatfield completes his appointment as Director of the Selective Service System on May 29, 2009. Executive Director Ernest Garcia assumes position as Acting Director until a new director is appointed.

Chatfield was the 11th Director, nominated by President George W. Bush and confirmed by the U.S. Senate. He has served in this position since November 29, 2004.

Among the few trademarks Chatfield leaves behind as his legacy is the promotion of a new branding of the agency at air shows across the United States, the preservation of the number of Reserve Force Officers in the field, and the addition of four states with driver's license legislation enacted.

On behalf of all Selective Service, Acting Director Garcia wishes Chatfield well in his future endeavors.



Three Employees Retire with Combined 80 Years of Selective Service System Experience

Beverly DeLong



On January 3, 2009, Beverly DeLong, operations manager, retired from the Selective Service System after nearly 43 years. She was honored at a retirement ceremony held at her church -Friendship Baptist Church - in Fairburn, GA, on January 11, 2009.

Beverly began

her career at Selective Service on April 11, 1966, when General Lewis B. Hershey was the national director. She entered the agency as an ungraded assistant clerk for the local boards in Fulton County, Atlanta, GA, making only \$4,814 per year. Beverly was selected for a clerk-typist position in the manpower division in the Georgia State Headquarters in 1969, and from there to a clerk-steno position in the classification division. She then served as the secretary to the state director until the agency went into deep standby and the state headquarters closed its doors in 1976. Beverly was asked to return from maternity leave to help close down the headquarters and was selected during that time for a position in the newly-formed mobilization training headquarters (MOTH) in Atlanta. [Later MOTH II became known as Region II Headquarters.] During her career with Region II, Beverly has also served in positions of secretary, operations staff officer, administrative officer (1984 - 2004), and operations manager.

Beverly has earned numerous awards during her tenure with Selective Service, some of which are the Selective Service Distinguished Service Award, the Selective Service Exceptional Service Award, Selective Service Meritorious Service Award, Selective Service Employee of the Quarter, 29 outstanding or higher performance ratings, numerous honorary state awards, and was nominated for Employee of the Year, Non-Scientific/ Professional. When Beverly was asked about things of interest during the time she has been with the agency, it was interesting to learn that she started her career during the Vietnam era; local boards were in every county in the state; and deferments were given if a man was married. "When word got out that the law would be changed, everyone rushed to get married before the change took effect. Then deferments were given for having children. I don't think they had time to have children before that was effective!" stated Beverly. Other milestones she mentioned were that Reserve Forces Officers assigned to the state headquarters drilled every Monday for four hours; the lottery became operational; the draft ended, the all-volunteer force was established; the registration requirement ended; and, the registration requirement was then reinstated.

"Many times we would get word from the FBI that someone would be demonstrating against the agency and they would be in front of our building the next day. We would have to get to the office before daylight (entering through a back door the next morning!!!). We were lucky we never had any major problems, unlike some of the offices throughout the United States where they had major demonstrations with offices and records burned."

Beverly has been an inspiration to all who have worked with her and we are very excited to wish her congratulations for the dedicated 42 years, 8 months, and 22 days of exceptional service she has given to the Selective Service System.

Sue Surdi

Sue Surdi retired April 3, 2009, with 38 years of Federal service. She describes herself as a "workaholic" for most of her career, and has been the recipient of many awards recognizing her accomplishments. She has thoroughly enjoyed the road she's traveled and has made many friends along the way.

Sue began her career in 1969, with the North Carolina Army National Guard as a clerk-typist and was later promoted to a payroll clerk with the U.S. Property and Fiscal Office. In 1975, she moved to Denver, CO, but could not find a Federal job. She worked in private industry as a secretary for Wang

at Pope AFB. She met her husband, Chuck, that year; and, in 1980, they married and moved to Marietta, GA. She transferred to the Department of Health and Human Services as a secretary, and later was promoted to a personnel clerk. In 1984, she accepted a payroll clerk position with the U.S. Army at Fort McPherson; and, in 1986, she transferred to the Defense Logistics Agency in Marietta, as a personnel clerk. In 1989, Sue transferred to the U.S. Army Recruiting Battalion Atlanta, as a clerktypist, was promoted to a budget and accounting assistant, and later was promoted to a support services specialist. In 1991, she was promoted to a realty specialist with the U.S. Army Recruiting Brigade at Fort Gillem, GA, where she enjoyed many challenging responsibilities. In 2000, she transferred to the Region II Headquarters of the Selective Service System as a program assistant. She was promoted to secretary to the region director in 2001; and, in 2005, was promoted to board program analyst. She states that Region II has been a wonderful place to work and one where she has enjoyed her time immensely.

Brenda reinstated her career in 1982, with the Selective Service System, Region II Headquarters, as a temporary clerk-typist in the training division. She assisted in areas of board member training and registration. This temporary position converted to a permanent position and she became the clerical assistant to the administrative officer. The position was later upgraded to the management services assistant. In 2005, she became the administrative officer and served in this position until April 3, 2009.

Awards include the Selective Service Exceptional Service Award, the Selective Service Meritorious Service Award, the Selective Service Employee of the Quarter, and many outstanding or higher performance ratings She was nominated for the outstanding Federal Secretarial/Clerical Employee of the Year.

She stated, "She was blessed to have Beverly DeLong as her supervisor, friend, and advisor for most of her employment with the Selective Service System." They bonded from day one and Beverly has always been her mentor.
