^{2/} The calendar year 2012 forecast includes estimated 2012 crop advance and final payments and forecast 2013 crop advance payments issued in December 2012. Since 2009, direct payments include direct payments from both sources: the Direct and Counter-Cyclical Program and the Average Crop Revenue Election Program.

^{3/} The estimates here include TTPP payments and lump-sum payments to quota holders and producers. The TTPP payments to private parties are not included.

^{4/} This category includes all conservation programs except for those considered as emergency assistance such as the Emergency Conservation Program.

^{5/} This category includes all programs providing disaster and other emergency assistance payments to growers including SURE payments disbursed from the Agricultural Disaster Relief Trust Fund.
