Publishing Early Findings: Eight Beacon Communities Presented at AcademyHealth Meeting

On February 14, 2012, eight Beacon Communities presented publication concepts at a Beacon Evidence and Innovation Network (BEIN) Workshop hosted by AcademyHealth in conjunction with the National Health Policy Conference in Washington, D.C. This workshop provided Beacon Community team members with an opportunity to discuss, vet, and refine their priority publication concepts with 10 assembled journal representatives and other health policy thought leaders.

Funded through the HHS Office of the National Coordinator for Health Information Technology (ONC), the Beacon Community Cooperative Agreement Program is part of a larger health care improvement revolution that demonstrates how health IT investments and Meaningful Use of electronic health records (EHR) advance the vision of patient-centered care, while achieving the three-part aim of better health, better care, and lower costs. Seventeen communities from Maine to Hawaii have received \$250 million in total over three years, and are nearly half way through the program.

"We want communities and policymakers across the country to benefit from the experiences of the Beacon Communities," said Craig Brammer, Director of the Beacon Community Program at ONC. "The communities have early evidence of their work and it's time to share these lessons with others."

The meeting was a combination of "pitch" presentations from the Beacon Communities and feedback from the journal editors and thought leaders.

AcademyHealth's President and CEO Lisa Simpson said, "The generation of relevant, actionable research is a core tenant of the work we do, and we were both impressed with the variety of paper concepts and encouraged by the interest expressed by participating journal editors in hearing about the Beacon Community Program experiences."
