Canadian Heart Health Initiative

Conceived in 1987, Launched in 1988

- Represents a "policy driven", systematic and evidence-based approach to:
 - Implement health promotion interventions
 - Build public health capacity in health promotion
- Apply current knowledge on prevention in diverse systems across Canada
- Uses heart health as entry point with a view to expand to other NCDs



Canadian Heart Health Initiative

Main goal: Focus on implementation; integrate and adapt known efficacious interventions into fabric of the public health infrastructure

Provided bridge between policy and practice


Deliver evidence-based preventive interventions

Build effective partnerships for CVD prevention at national, regional and local levels




Partnership and Linkage Model

Policy Development (1986 to 1988)

- Federal/Provincial working group recommendations
 - **Consultations with stakeholders**
- Consensus approach to Policy Framework
- "Promoting Heart Health in Canada" (1987)



Provincial Heart Health Surveys (1986-92) 10 provincially-based surveys were conducted Built provincial capacity **Risk factor data and physical** measurement Media / Marketing for visibility Consolidated into one national database – **The Canadian Heart Health Database** Health Santé

Demonstration Phase (1989-97)

- To determine feasibility of implementing a comprehensive approach to CVD prevention at the community level
 - 311 community-based provincial heart health projects in 10 provinces
- Risk factor focus: tobacco, physical activity, nutrition



Process Evaluation (1992-99)

- Process evaluation guidelines developed
- Canadian Heart Health Evaluation Database

Increased capacity of public health departments to monitor and implement prevention programs

Dissemination Projects

Objectives

Measure current levels of capacity and dissemination for heart health programming in both community wide and individual centred approaches at all levels

Determine factors that support and impede capacity building and dissemination of best clinical and community practices in heart health promotion

 To inform the field of dissemination research and capacity building in order to deliver evidencebased disease prevention efforts in Canada

 - ... a national action plan for chronic disease in Canada
- Provincial Alliances



Advancing the Knowledge Base To guide integrated action

New "demonstration sites" to evaluate and monitor integrated NCD prevention approaches

Some Key Achievements

- Extensive database on behavioural risk factors
 - Potential linkage to mortality and morbidity data
- Coalitions for heart health at all levels expanded to chronic disease alliances
 - Flexible network management model for pan-Canadian initiatives in a decentralized environment
- Practical knowledge on planning and evaluation
- Link to international efforts such as WHO CINDI/CARMEN
