Dear Mr. McFarland:

We have reviewed the system of internal safeguards and management procedures for the investigative operations of the U.S. Office of Personnel Management (OPM). Office of Inspector General (OIG), in effect for the fiscal year ending on September 30, 2009. Our review was conducted in conformity with both the *Quality Standards for Investigations* (December 2003) and the *Qualitative Assessment Review Guidelines for Federal Offices of the Inspector* General (May 2009) established by the Council of the Inspectors General on Integrity and Efficiency (CIGIE) as well as the *Attorney General Guidelines for Offices of the Inspector General with Statutory Law Enforcement* Authority (December 2003).

The review was conducted at the OPM/OIG headquarters office in Washington, DC. We reviewed compliance with OPM/OIG's system of internal policies and procedures to the extent we considered appropriate. We interviewed operational and management personnel and we reviewed a sample of thirty closed case files from among one-hundred twelve investigations OPM/OIG closed during the fiscal year ending on September 30, 2009.

In performing our review, we gave consideration to the prerequisites of Section 6(e) of the Inspector General Act of 1978 (as amended) and Section 812 of the Homeland Security Act of 2002 (Pub.L. 107-296). Those documents authorize law enforcement powers for eligible personnel of each of the various offices of presidentially appointed Inspectors General. Those powers may be exercised only for activities authorized by the Inspector General Act of 1978, other statutes, or as expressly authorized by the Attorney General.
