Qualified Electronic Health Record (EHR) Direct Vendors for the 2012 Physician Quality Reporting System and Electronic Prescribing (eRx) Incentive Programs

Some EHR Direct vendors are also capable of reporting the electronic prescribing (eRx) measure to CMS as listed in the following table. In addition to capturing the required data elements for the measure calculation, these "qualified" EHR products can transmit the required information in the requested file format. While the listed EHR Direct vendors and their qualified EHR system and product(s) have successfully completed the vetting process, CMS cannot guarantee that any other product or version of software, other than what is listed in this document, will be compatible for EHR-based submission for the Physician Quality Reporting System or the Electronic Prescribing Incentive Program. Due to an extended testing period, some vendors may have additional capabilities that are not listed on this posting. Please check with the vendor for additional information.

Eligible professionals who wish to participate in the 2012 Physician Quality Reporting System and/or Electronic Prescribing Incentive Program using the EHR-based reporting option may contact the EHR Direct vendors listed on the following pages for additional details about their software. Please note: You will need an IACS account to submit your data directly from your EHR to CMS. The data submission period for program year 2012 is currently scheduled for January 1, 2013 to February 28, 2013.
