RESPONDENT'S MOTION FOR EXTENSIONS OF TIME

Pursuant to Rules 3.21(c)(2) and 4.3(b) of the Rules of Adjudicative Practice of the Federal Trade Commission, Respondent North Carolina State Board of Dental Examiners ("Respondent" or the "State Board") respectfully requests that the Administrative Judge grant Respondent an extension of time until December 17, 2010, to serve its designated testimony to be presented by deposition, and an extension of time until December 21, 2010, to serve its final proposed exhibit list, copies of all exhibits, and Respondent's basis of admissibility for each proposed exhibit.

In support hereof, Respondent shows unto the Administrative Law Judge that:

- 1. - 4. Respondent's Counsel has conferred with opposing counsel in an effort in good faith to resolve by agreement the issue raised by this Motion, and Complaint Counsel has indicated that they will not oppose this Motion.
- 5. None of the requested extensions will affect the scheduled trial date in this matter or any other deadlines set by Scheduling Order.

WHEREFORE, Respondent respectfully requests that the Administrative Law Judge grant:

- 1. An extension of time until December 17, 2010, for Respondent to serve its designated testimony to be presented by deposition; and
- 2. An extension of time until December 21, 2010, for Respondent to serve its final proposed exhibit list, copies of all exhibits, and Respondent's basis of admissibility for each proposed exhibit.
