- 6. Respondent further moves to strike the following matters and information presented in Dr. Giniger's Rebuttal Report, all of which do not rebut matters set forth in Dr. Haywood's Expert Report:
 - page 1 entire first paragraph
 - page 4 second full paragraph
 - page 5 first paragraph under heading III
 - page 23 entire page
 - page 24 first partial paragraph

7. Counsel for Respondent has conferred with Complaint Counsel about this Motion for Leave and to Strike (in part), and Complaint Counsel have indicated that they will oppose this motion.
