RESPONDENT'S MOTION FOR EXPEDITED EXTENSIONS OF TIME

Pursuant to Rules 3.21(c)(2) and 4.3(b) of the Rules of Adjudicative Practice of the Federal Trade Commission, Respondent North Carolina State Board of Dental Examiners ("Respondent" or the "State Board") respectfully requests that the Administrative Judge grant Respondent an extension of time until 5:30 p.m. on April 22, 2011, to file its Post-Trial Brief and Proposed Findings of Fact, Conclusions of Law, and Proposed Order. In the event such extension is granted, Respondent respectfully requests that the Administrative Law Judge grant Complaint Counsel the same extension of time to file its Post-Trial Brief and Proposed Findings of Fact, Conclusions of Law, and Proposed Order.

In support hereof, Respondent shows unto the Administrative Law Judge that:

- Currently, Respondent's and Complaint Counsel's Post-Trial Brief and Proposed Findings of Fact, Conclusions of Law, and Proposed Order are due April 20, 2011, pursuant to the Order on Post Trial Briefs entered March 30, 2011.
- Pursuant to the same Order, Respondent and Complaint Counsel have a deadline of May 2, 2011 to file reply briefs and replies to the proposed findings of fact.

- Respondent's counsel has been diligently working towards the current April 20th deadline.
- 4. On April 16, 2011, a tornado passed through downtown Raleigh very close to the offices of Respondent's counsel. Fortunately, there was no direct impact on the property of Respondent's counsel; however, electrical power was cut off to the offices of the firm and the residences of some of its attorneys and staff for a substantial period of time. Power did not return to Counsel's office building until about 2:15 a.m. Sunday morning.
- During that time period, it was not possible to work on the preparation of the Post-Trial Brief and Proposed Findings of Fact, Conclusions of Law, and Proposed Order.
- 6. Respondent's Counsel has consulted with Complaint Counsel and can represent that, in the event Respondent's Motion for Extensions of Time to extend until April 22, 2011 the deadline for both Respondent's counsel and Complaint Counsel to file their Post-Trial Brief and Proposed Findings of Fact, Conclusions of Law, and Proposed Order is granted, Complaint Counsel supports Respondent's request that the Administrative Law Judge grant the extension.
- 7. Respondent's Counsel has conferred with opposing counsel in an effort in good faith to resolve by agreement the issue raised by this Motion, and Complaint Counsel has indicated that they will not oppose this Motion.
- 8. None of the requested extensions will affect the deadline to file reply briefs or replies to the proposed findings of fact on May 2, 2011, or the scheduled closing arguments date of May 5, 2011, or any other deadlines.

WHEREFORE, Respondent respectfully requests that the Administrative Law Judge grant:

- An extension of time until 5:30 p.m. on April 22, 2011 for Respondent and Complaint Counsel to file their respective Post-Trial Brief and Proposed Findings of Fact, Conclusions of Law, and Proposed Order.
 - All other deadlines in the Scheduling Order would remain the same.
