RESPONDENT ASPEN TECHNOLOGY, INC.'S UNOPPOSED MOTION FOR FURTHER LIMITED EXTENSION OF DISCOVERY DEADLINE

Respondent Aspen Technology, Inc. ("AspenTech") respectfully requests that the close of discovery for the limited purpose of obtaining discovery from Heat Transfer Research, Inc. ("HTRI") on heat transfer software be extended until April 30, 2004.

Pursuant to Your Honor's March 2, 2004 order, AspenTech promptly served a subpoena *Duces Tecum* on HTRI and a subpoena *Ad Testificandum* on Mr. Fernando Aguirre, whom Complaint Counsel has designated as a witness. AspenTech requested, and on March 15, 2004, Your Honor granted an extension of the close of discovery for the limited purpose of obtaining discovery from HTRI until April 9, 2004. On March 30, 2004, HTRI produced nine boxes of documents in response to AspenTech's subpoenas.

Due to scheduling conflicts, AspenTech will be unable to take the deposition of Mr. Aguirre on April 7, as previously scheduled. HTRI's counsel has informed AspenTech that Mr. Aguirre will be out of the country until April 20, 2004, and otherwise unavailable until April 29, 2004. After conferring with Complaint Counsel and further consultation with HTRI's counsel yesterday, all have agreed that the deposition of Mr. Aguirre may be rescheduled to April 29, 2004. Accordingly, AspenTech respectfully requests that the close of

discovery for the limited purpose of obtaining discovery from HTRI on heat transfer software be extended until April 30, 2004.

This extension will not affect any other deadline on the Second Revised Scheduling Order. Complaint Counsel has indicated that they do not oppose the extension of discovery for the limited purpose of obtaining discovery from HTRI to April 30, 2004.
