Dear Sir or Madam:

With the single exception discussed next, Intel Corporation does not object to the Commission's proposed publication of the entirety of the nonpublic version of the Opinion and Order of the Commission Denying Motion for Disqualification, dated January 19, 2010, including the Statement of Commissioner J. Thomas Rosch on Respondent's Motion for Disqualification, dated December 18, 2009, that is appended to the Commission's Opinion and Order.

Intel continues to maintain its objection to the publication of the redacted material on page 3 of Commissioner Rosch's Statement identified in Intel's letter of January 20, 2010. In the current public version, that passage now reads:

Beyond that, to this Commissioner's knowledge, Intel did not engage in **[redacted]** during this Commissioner's representation, and the motion does not contain any evidence that this Commissioner made representations to the Commission staff or anyone else about those practices. (Mot. at 2.)

As stated in our January 20, 2010 letter, the redacted portion of this statement characterizes Intel's conduct based on confidential information that Commissioner Rosch acquired in the course of his long-time representation of Intel as its principal outside antitrust counsel. Information communicated to Commissioner Rosch as then-counsel to Intel concerning particular sales practices is confidential to Intel and privileged. Intel has not authorized Commissioner Rosch to disclose such information. Intel therefore requests that the Commission continue to withhold this information from the public record.

In light of the Commission's decision to disclose certain redacted information in its Opinion and Order, Intel hereby also withdraws its request for confidential treatment of its Motion for Disqualification of Commissioner J. Thomas Rosch, and requests that the Secretary publish the

nonpublic version of that Motion, including all attachments, in its entirety and without redaction at the same time as the Commission publishes in fuller text the Opinion and Order relating thereto.
