NOTICE OF WITHDRAWAL OF INTEL'S MOTION FOR EXTENSION OF TIME AND FOR LEAVE TO FILE OVER-LENGTH MEMORANDUM IN OPPOSITION TO COMPLAINT COUNSEL'S MOTION TO ADMIT EUROPEAN COMMISSION DECISION

Respondent Intel Corporation ("Intel") hereby withdraws its Motion for Extension of Time and for Leave to File Over-Length Memorandum in Opposition to Complaint Counsel's Motion to Admit European Commission Decision, filed on March 23, 2010, in light of an agreement the Parties reached at the status conference on March 25, 2010.
