# **Chapter 1: Introduction**

# Unique IPA Identifier (UII) Registration System

### System Purpose

HUD's Uniform Financial Reporting Standards (UFRS) regulations, codified at 24 CFR part 5, subpart H (issued by final rule on September 1, 1998 at 63 FR 46582) require covered program participants to submit electronically to HUD, on an annual basis, audited financial information prepared in accordance with generally accepted accounting principles (GAAP). HUD's Real Estate Assessment Center (REAC), through its Financial Assessment Subsystems (FASS), is responsible for collecting and assessing submissions covered under the UFRS.

Firms and governmental organizations who perform audit and attestation engagements for clients covered by the UFRS are required to apply for and obtain from REAC – through the UII Registration System – an identification code called a Unique IPA<sup>1</sup> Identifier (UII). Firms with multiple office locations must separately register and obtain a UII for each of their offices that perform professional services for covered program participants. Sole practitioners and firms with a single office location also must apply for a UII.

The purpose of the UII Registration System is to provide HUD with a uniform listing – by office location – of the firms who provide audit and attestation services to clients covered by the UFRS. Upon successful completion, the system issues the registering firm's office a five-digit randomly generated number – the UII. Effective on and after the following dates, FASS will require your client(s) to include your UII with their annual audit submission:

- Public Housing Authorities covered by the UFRS and the Public Housing Assessment System (PHAS) regulations – February 2, 2001.
- Multifamily program participants covered by the UFRS February 9, 2001.

Practitioners must be registered with HUD's Secure Connection system before they can register their office location in the UII Registration System.

#### System Environment

The UII Registration System is a secure Web-based system accessible on the Internet through the REAC's web site.

# **Chapter 2: Getting Started**

# Initial Browser Settings

To use the UII Registration System, the user's Internet browser must be set to accept cookies. A "cookie" is a file automatically stored on the user's computer.

To set the browser to accept cookies:

- 1. From the desktop, double click on your Internet browser icon. The initial page displays.
- 2. Single click on Edit on the menu bar, at the top of the tab page, to view the list of edits options.



- 3. Single click on the Preferences option to select it. The **Preferences** settings window displays.
- 4. Single click on Advanced in the *Category* list to select it. The **Advanced** preferences settings window displays.



- 5. Under the *Cookies* heading, single click on the "Accept all cookies" radio button to select it.
- 6. Single click on the OK push button to continue.

# **Chapter 3: Accessing the Ull Registration System**

To create, recall or update an auditor office's contact information via the Internet using the UII Registration System, a User must:

- Be registered with HUD's Secure Connection and have a valid HUD user ID<sup>2</sup>
  - Be assigned the appropriate FASS system role by your Coordinator as follows:
    - **IPA or State Auditor for PHA Entity:** Be assigned a Certified Public Accountant (CPA) Validator (CPV) role
    - **IPA or State Auditor for MF Entity:** Be assigned a Certified Public Accountant (CPA) Certifier (CPC) role

# Logging Into the UII Registration System

1. Go to the **real estate assessment center** Web site. Type in the following address in the URL locator: <u>www.hud.gov/offices/reac</u>



 On the home page of the real estate assessment center Web site (www.hud.gov/offices/reac), single click on the <u>online systems</u> link in the left column. The online systems page displays.

- 3. On the **online systems** page, single click on the Log In **Username and Password Required** window displays.
  - NOTE: If a **Registration Certification** box displays, single click on the Continue Continue push button to close the box and continue to the **Username and Password Reguired** window.

- 4. Enter your HUD user ID in the *User Name* field. The user ID is case-sensitive; remember to capitalize the letters in your user ID. *Do not enter your name in the User Name field.*
- 5. Using the Tab key on the keyboard, move to the *Password* field. Enter your password. The password is also case-sensitive (uppercase/lowercase); enter the password exactly as you requested it on the registration application.

6. Single click on the OK push button. A **Legal Warning** page displays.



7. Read the warning, and single click on the Continue push button. The **Secure Systems** page displays.



8. Under the *Systems* heading, single click on the underlined <u>Unique IPA Identifier (UII)</u> <u>Registration System</u> link to access the system. The **Main Menu** page displays.

# Chapter 4: Register for a UII

This chapter describes the process of registering for a UII. After the user successfully logs in and selects the Unique IPA Identifier (UII) Registration System link from the Secure System main page, the **Main Menu** page displays (see Chapter 3).

#### Step 1: Single click the Create New Profile link from the Main Menu

#### Select Audit Office Classification Page

The **Select Audit Office Classification** page displays. The user selects whether they are registering an Independent Public Accounting Office (e.g. CPAs and PAs) or a State Auditor Office (governmental audit organizations).



#### Step 2:

IPA user: Single click the Independent Public Accounting Office link State Auditor user: Single click the State Auditor Office link

The **Create IPA Office Profile** displays. The EIN and Zip Code combination is used to identify an office.

# **Chapter 5: Update a Profile**

This chapter describes to the process of updating an Office Profile in the UII Registration System. In order to gain access to an office's registration profile, the user must enter their office's UII number. If you have forgotten your UII, please refer to Chapter 6 for instructions on how to retrieve your UII number.

After logging in and selecting the Unique IPA Identifier (UII) Registration System link from the Secure System main page, the UII Registration System Main Menu page displays (see Chapter 3).

The Main Menu page provides the user with the option to either Create a New Profile, Update Existing Profile, or Recall Unique IPA Identifier (UII).

#### Step 1: Single click the Update Profile link from Main Menu

# Appendix A: Secure Systems Registration Guide

The following outlines the steps necessary for a CPA to properly obtain and configure a Secure Systems ID in order to access the Unique IPA Identifier (UII) Registration system.

#### If you already have a Secure Systems ID, go directly to Step 3 of the registration process.

#### Step 1: Obtain a Secure Systems ID

#### If you do not have a Secure Systems ID:

- Contact an entity for whom you are engaged to perform an audit and/or agreed upon procedures engagement. Indicate to their Secure Systems Coordinator that you need to register for an ID under the entity. Obtain the entity name and TIN/SSN (employer identification number) if they are a Multifamily Owner/Agent or entity name and organization ID if they are a Public Housing Authority (i.e. NY123 for a New York PHA).
- Go to URL: <u>www.hud.gov/offices/reac</u>
- Click the online systems link.
- On the online systems page under the heading "Need a User ID?", click the Mutifamily Housing Entity link if you are engaged to perform an audit and/or agreed upon procedures engagement for a Multifamily Owner/Agent or click the Public Housing Authority link if you are engaged perform an audit and/or agreed upon procedures engagement for a Public Housing Authority.
- On the Secure System Registration screen complete the registration form. Ensure you select that you are registering as a User, not a coordinator.
   Note: If you are registering under a Multifamily Owner/Agent the Organization/Individual Information refers to the HUD-registered organization you will be doing business with. Therefore the Organization/Individual Name and TIN/SSN (employer identification number) you enter in this section must be that of the Multifamily Project Owner/Agent.
- Click Send Application.

#### Step 2: Retrieve Your Secure Systems ID

• Wait 24 hours after you have registered and then ask your Public Housing Authority or Multi Family Project Coordinator to retrieve your user ID (instructions are available on the **online systems** page).

# Step 3: Assign QASS Coordinator Action to the PHA / MF entity Coordinator's ID (This step must be performed by the PHA / MF entity Coordinator.)

- Go to URL: <u>www.hud.gov/offices/reac</u>
- Click the online systems link.
- Click the Log In button.
- Enter the PHA / MF entity Coordinator ID and Password.
- From the Secure Systems Main Menu click the User ID Maintenance link.

- On the System Administration screen enter in the Coordinator ID and select the **Maintain User Profile** option. Click Submit.
- On the Maintain User Profile screen scroll down to the **QASS** system. Click the check boxes to the left of QASS and to the left of Action(s).
- Highlight **Coordinator** from the left hand (Add to) text area.
- Scroll to the bottom of the page and click **Update**.
- A confirmation screen will be displayed.

# Step 4: Categorize User as a QASS User (This step must be performed by the PHA / MF entity Coordinator.)

#### Assign Submit QASS Profile Action to the User's ID:

- Go to URL: <u>www.hud.gov/offices/reac</u>
- Click the **online systems** link.
- Click the Log In button.
- Enter the PHA / MF entity Coordinator ID and Password.
- From the Secure Systems Main Menu click the User ID Maintenance link.
- On the System Administration screen enter in the user's ID and select the **Maintain User Profile** option. Click Submit.
- On the Maintain User Profile screen scroll down to the **QASS** system. Click the check boxes to the left of QASS and to the left of Action(s).
- Single click the Submit QASS Profile from the left hand (Add to) text area.
- Scroll to the bottom of the page and click **Update**.
- A confirmation screen will be displayed.

#### If the CPA has registered under a Multifamily Entity:

- From the Secure Systems Main Menu click the User ID Maintenance link.
- On the System Administration screen enter in the user's ID and select the **Maintain User Information** option. Click Submit.
- On the Maintain User screen. Click the check box to the left of Assign Role(s).
- Single click **FASSUB CPA Certification** from the Assign Role(s) scroll down box.
- Click the **Update** button.
- A confirmation screen will be displayed.

#### If the CPA has registered under a Public Housing Authority:

- From the Secure Systems Main Menu click the User ID Maintenance link.
- On the System Administration screen enter in the user's ID and select the **Maintain User Information** option. Click Submit.
- On the Maintain User screen. Click the check box to the left of Assign Role(s).
- Single click **FASPHA CPA Validation** from the Assign Role(s) scroll down box.
- Click the **Update** button.
- A confirmation screen will be displayed.
