17.Helping provider find out if she or he is an "individual" or "organization" in PECOS		Χ

<ul> <li>Physician Beth wants to enroll in Medicare and reassign her benefits to an organization she owns. Beth wants to know if she is considered an individual provider or an organization because she plans to use a TIN when she bills.</li> </ul>
