Training Requirements for Realty Leasing Contracting

Officers

- 1. <u>Purpose</u>. This Acquisition Letter makes a change to the leasing training requirement for the Contracting Officer Warrant Program. The number of hours required for the course entitled, Real Estate Appraisal Principles, in the curriculum for lease acquisition warrants, is changed from 40 hours to 30 hours.
- 2. Background. The GSAM currently requires leasing specialists to take a 40 hour appraisal course. The training provider is the Appraisal Institute. Their courses are recognized by all states for the licensing of appraisers to operate in the state. The Appraisal Institute has reduced the current course, Real Estate Appraisal Principles, from a 40 hour course to a 30 hour course. The course was changed from 40 hours to 30 hours to better align individual state training requirements for licensed appraisers and trainees. Therefore, the number of hours required for the Real Estate Appraisal Principles course, in the curriculum for lease acquisition warrants, is changed from 40 hours to 30 hours.
- 3. Effective Date: Date of issuance:
- 4. <u>Termination Date</u>. This Acquisition Letter remains in effect until the GSAM is amended.
- 5. <u>Changes</u>: The Real Estate Appraisal Principles course prescribed in Figure 501-2, entitled Warrant Requirements for Personal Property Disposal, Real Property Disposal, and Realty Leasing Contracting Officers, is changed from 40 hours to 30 hours.
- 6. <u>Instructions/procedures</u>: Figure 501-2, Warrant Course Requirements, replaces the version revised by MV Acquisition Letter 04-03.
