## National Park Service Seeks Public Comments about Future Proposed Construction Work at Sequoia National Park

Three Rivers, CA – The National Park Service (NPS) seeks public comments about proposed road construction at Sequoia National Park in a new environmental assessment (EA) that analyzes the next two phases of a major rehabilitation and reconstruction project. Specifically, the EA focuses on work along 7 miles of the Generals Highway between Deer Ridge and Wolverton Road, as well as work along Wolverton Road (1.3 miles long). New pullouts and improvements at intersections and parking areas along the highway are components of the project. The overall goal of the project is to correct structural deficiencies and reduce maintenance requirements, as well as to provide for improved visitor enjoyment and safety while protecting the parks' scenic, natural, and cultural resources. Even if a commenter requests to have personal identifying information withheld, the NPS cannot guarantee this will be done. The NPS will always make submissions from organizations or businesses, and from individuals identifying themselves as representatives of or officials of organizations or businesses, available for public inspection in their entirety. *Anonymous comments will not be accepted.* 

The Generals Highway, which was constructed in 1935, periodically needs repairs to correct deterioration (structural deficiencies and normal wear). The preferred alternative includes repairs and improvements to address inadequate drainage, subgrade slumping, pavement cracking, potholes, and other structural problems. If approved, the project could begin as early as 2014, depending upon funding.
