#### MEMORANDUM OF UNDERSTANDING BETWEEN DEFENSE ACQUISITION UNIVERSITY AND AMERICAN GRADUATE UNIVERSITY

- We, the undersigned, hereby agree and affirm the establishment of the cooperative graduate degree and professional certificate programs between the Defense Acquisition University (DAU) and the American Graduate University (AGU), leading to a graduate degree in the following two areas: Acquisition Management and Program/Project Management and four Professional Certification areas: Acquisition, Project/Program Management, Financial Management and Pricing, and General Management. The graduate degree and certificate programs will be subject to the following terms and conditions:
  - a. The cooperative graduate degree and professional certificate programs will utilize the education, training, and experiences of the members of the Defense Acquisition, Technology, and Logistics (AT&L) workforce received in pursuit of DAU level of certification in at least one of the Defense Acquisition Workforce Improvement Act (DAWIA) career fields in conjunction with graduate courses offered by AGU.
  - b. The Graduate Degree Program and Professional Certificate Program will be available to any member of the Defense AT&L workforce. A Bachelor's degree from a regionally accredited university is required for admissions for the Graduate Degree Program. A minimum of Level I Certification in at least one DAU career field is required for admission to the Professional Certification Program.
  - c. Graduate Degree and Certificate Completion Requirements: Each Defense AT&L workforce member must complete the required number units of credit for the graduate degrees or six courses for a professional certificate program. The program of study is outlined in the current AGU catalog, which is available on the World Wide Web at http://www.agu.edu.
    - (1) Depending on the career field, level of certification and choice of graduate program or professional certificate, the AT&L workforce member will receive up to 6 units of general graduate level credit toward the specified graduate degree or professional certificate. The AT&L workforce member will be able to challenge for an additional 9 units based on transcript evaluation for the graduate degree programs. This credit will be designated as "advance standing" on the transcript for up the six units. The Professional Certification Programs (Attachment 1) and the Graduate Degree Programs (Attachment 2)

Degree Programs (Attachment 2) will identify the course in the respective programs that DAU course will be accepted for credit.

- (2) The remaining graduate degree or professional certificate requirements must be completed by either distant education or by resident courses offered by AGU. A cumulative GPA of 3.0 must be obtained in order to be awarded the graduate degree or professional certificate.
- d. Students are responsible for tuition funding of the cost per unit, which will be no more that that charged for resident courses.
- e. Under this Memorandum of Understanding (MOU), the AGU will:
  - (1) Provide administrative support services to include advising and assisting students desiring to enter the program, and promoting and advertising of the programs throughout the Defense AT&L workforce.
  - (2) Provide DAU with information as required for planning, conducting, and reporting of DAU's operation.
  - (3) Conduct resident courses when there is a minimum of ten students enrolled for a course. Courses will normally be split when there are 30 or more students.
  - (4) Provide qualified and experienced instructors to conduct the courses.
  - (5) Award credit to any student registered with AGU for that purpose who successfully completes all requirements for the course.
  - (6) Render a report showing the final grade assigned, at no charge, to each student enrolled in a course.
- f. Under this MOU, the DAU will:
  - (1) Assist with outreach and communications promoting the graduate degree and professional certification programs and provide suggestions for adjusting content of academic courses to meet the changing needs of the programs and Defense AT&L workforce requirements.
  - (2) Provide student transcripts for DAU courses for students applying for the graduate degree and professional certificate programs.
  - (3) Students will arrange official proof of DAWIA certification status.
- 2. Both parties to this MOU intend to conduct the cooperative graduate degree and/or professional certificate programs on a continuing basis, subject to at least an annual review of

academic matters, and subject to sufficient student participation, the nonconcurrence of which will result in no liability to the Government. All academic policies and regulations of the AGU are understood to apply to these programs.

- 3. Either party reserves the right to terminate, without liability, the cooperative graduate degree and/or professional certificate programs when the interest of that party so dictates. Every effort will be made by either party to give 60-days notice prior to effective date of termination and to complete the then-current programs year. Credits awarded to the point immediately preceding termination will be considered AGU units. AGU understands that the DAU support described in paragraph 1.f. of this MOU is provided with no guarantee of continuation of that support.
- 4. The parties hereto agree, understand, and acknowledge that this cooperative graduate degree and/or professional certificate programs shall be without cost or liability to the United States Government.
