CONSUMER EXPENDITURES FOR THE HOUSTON AREA: 2009 – 2010

Consumer units¹ (households) in the Houston-Galveston-Brazoria metropolitan area spent an average of \$56,764 per year in 2009-2010, the U.S. Bureau of Labor Statistics reported today. Regional Commissioner Stanley W. Suchman noted that this figure was nearly 17 percent above the \$48,588 average annual expenditure level for a typical household in the United States. Although households in the Houston area spent more than the U.S. average, they tended to allocate their dollars similarly among the major categories, differing significantly in only one of the eight. (See chart 1.). Expenditures for food represented a significantly smaller share of the total budget in the Houston area, 11.6 percent, than the nationwide average of 12.9 percent.




Chart 1. Percent distribution of average annual expenditures for eight major categories in the Houston metropolitan area and the United States, 2009–2010

Housing in the Houston metropolitan area averaged \$19,323 annually and was the largest expenditure category, accounting for 34.0 percent of the average Houston area household's total budget. (See tables 1 and 2.) This share was not significantly different from the 34.4-percent national average. Overall, 10 of the 18 published metropolitan areas had expenditure shares for housing measurably above the U.S. average; only Detroit had a significantly lower than average share. (See chart 2.) Among the 18 areas, housing shares ranged from 43.6 percent in Miami to 32.6 percent in Detroit. (See table 3.)

The majority of total housing expenditures in Houston went toward shelter, 56.4 percent, which includes mortgage interest, property taxes, repairs, and rent, among other items; this was significantly below the 59.4-percent share allocated toward shelter nationwide. (See table A.) In contrast, expenses for utilities, fuels, and public services accounted for 23.5 percent of the local housing budget, well above the national average of 21.8 percent. The rate of homeownership in Houston, 68 percent, was above the U.S. average of 66 percent.

At 16.6 percent of the total budget, transportation was the second-largest expenditure category in the Houston area and was not significantly above the national average of 15.8 percent. Among the 18 metropolitan areas nationwide, only Detroit had a transportation share that was significantly above average. (See chart 3.) Among the remaining areas, six had significantly lower shares than the U.S. average, the lowest being Baltimore at 12.4 percent, followed by San Francisco at 12.6 percent.

Of the \$9,410 in annual expenditures for transportation in Houston, 94.4 percent was spent buying and maintaining private vehicles compared to the national average of 93.7 percent. Despite the higher local area transportation share, the average number of vehicles per household in Houston (2.0) was comparable to the national average (1.9). The remaining 5.6 percent of the average Houston household's transportation budget was spent on public transit—which includes fares for taxis, buses, trains, and planes; this was below the 6.3-percent average for the nation. (See table B.) Among the 18 areas, public transportation budgets accounted for more than 10 percent of local transportation expenditures in 4 areas, led by New York (13.5 percent) and San Francisco (12.5 percent).

The portion of the average Houston consumer unit's budget spent on food, 11.6 percent, was significantly below the U.S. average share of 12.9 percent. Houston was 1 of 7 metropolitan areas with food expenditure shares significantly below the U.S. average; no area had food expenditure shares significantly above the national average. The lowest food shares were in Seattle and Washington, D.C., both at 11.0 percent.

Households in Houston spent \$3,527, or 53.4 percent, of their food dollars on food at home and the remaining 46.6 percent on food away from home, such as restaurant meals, carry-out, board at school, and catered affairs. In comparison, the typical U.S. household spent 59.0 percent of its food budget on food at home and 41.0 percent on food away from home.

As noted, Houston is 1 of 18 metropolitan areas nationwide for which Consumer Expenditure Survey (CE) data are available. Additional Information

Data contained in this report are from the Consumer Expenditure Survey, which is conducted on an ongoing basis by the U.S. Census Bureau for the Bureau of Labor Statistics (BLS). The CE data were averaged over a two-year period, 2009 and 2010 and are available for the nation, the 4 geographic regions of the country, and 18 metropolitan areas. The metropolitan area discussed in this release is Houston-Galveston-Brazoria, Texas, which is comprised of Austin, Brazoria, Chambers, Fort Bend, Galveston, Harris, Liberty, Montgomery, San Jacinto, and Waller Counties.

The survey consists of two components, a diary or recordkeeping survey, and an interview survey. The integrated data from the BLS Diary and Interview Surveys provide a complete accounting of consumer expenditures and income, which neither survey component alone is designed to do. Due to changes in the survey sample frame, metropolitan area data in this release are not directly comparable to those prior to 1996.

A consumer unit is defined as members of a household related by blood, marriage, adoption, or other legal arrangement; a single person living alone or sharing a household with others but who is financially independent; or two or more persons living together who share responsibility for at least 2 out of 3 major types of expenses – food, housing, and other expenses. The terms household or consumer unit are used interchangeably for convenience.

The expenditure data in this release should be interpreted with care. The expenditures are averages for consumer units with the specified characteristics, regardless of whether a specific unit incurred an expense for that specific item during the recording period. The average expenditure may be considerably lower than the expenditure by those consumer units that purchased the item. This study is not intended as a comparative cost of living survey, as neither the quantity nor the quality of goods and services has been held constant among areas. Differences may result from variations in demographic characteristics such as consumer unit's budget spent on a particular category, can be used to compare spending patterns across areas. Users should also keep in mind that prices for many goods and services have changed since the survey was conducted.

The CE significance tests in this release compare expenditure shares for selected expenditure categories in the United States to expenditure shares in selected metropolitan areas. (See table 3.) Expenditure shares for housing and transportation that are above or below that for the nation after testing for significance at the 95-percent confidence interval are also identified in charts 2 and 3 for the 18 metropolitan areas surveyed. Sample sizes for the metropolitan areas are much smaller than for the nation, so the U.S. estimates and year-to-year changes are more reliable than those for the metropolitan areas.

<u>NOTE</u>: A value that is statistically different from another does not necessarily mean that the difference has economic or practical significance. Statistical significance is concerned with the ability to make confident statements about a universe based on a sample. It is entirely possible that a large difference between two values is not significantly different statistically, while a small difference is, since both the size and heterogeneity of the sample affect the relative error of the data being tested.




