LENDERS SELECTED FOR LOW INCOME HOUSING TAX CREDIT PILOT PROGRAM

FHA Multifamily Development supports production of affordable housing, and encourages all of its qualified MAP Lenders to submit FHA mortgage insurance applications for projects with Low Income Housing Tax Credits in all HUD jurisdictions. Lenders should contact the Multifamily Program Center or Hub with jurisdiction to discuss potential tax credit or other FHA transactions.

In addition to the general availability of FHA mortgage insurance supporting Tax Credit production, HUD also launched the Multifamily Low Income Housing Tax Credit Pilot Program in February. (See Notice H-2012-1 and Mortgagee Letter H-2012-1.) Four Hubs were selected to participate in the pilot program: Boston, Chicago, Detroit, and Los Angeles. Twenty lenders (listed below) have been approved for Pilot Program participation. As of April 19th, new Tax Credit project mortgage insurance applications may be accepted at the Pilot Hub Offices, and for the subsequent 45 days lenders may also submit "transfer projects" that meet the Pilot Program parameters and are already under review at the Pilot Hubs.
