An in-depth view of total per capita health spending across the nation plus insights about the effects of the recent recession and recent health policy initiatives.

Flu shots and the characteristics of unvaccinated elderly Medicare beneficiaries

Flu vaccination rates among elderly Medicare beneficiaries increased with age but were significantly lower for certain vulnerable populations. A physician office or community setting; e.g., grocery store were the most common places beneficiaries reported getting a flu shot.

<u>Disparities in Routine Breast Cancer Screening for Medicaid Managed</u> <u>Care Members with a Work-Limiting Disability</u>

Women with a disability are found less likely than those without a disability to seek breast cancer screening.

Indirect Medical Education (IME) and Disproportionate Share Adjustments (DSH) to Medicare Inpatient Payment Rates

Provides 1) evidence that IME payments would be smaller under an empirical method—about one-third to one-half—than the method prescribed by current law, and 2) support for the DSH adjustment prescribed by the Affordable Care Act of 2010.

<u>How Does the Volume of Post-Acute Care Respond to Changes in the Payment Rate?</u>

SNF volume responses are affected by admissions, payer mix changes, and total days of Medicare-covered institutional care, rather than length of stay, capacity changes, or a substitution of one setting for another.
