REQUEST FOR ORAL ARGUMENT

Upsher-Smith Laboratories, Inc. ("Upsher-Smith") requests that the Administrative Law Judge hear oral argument on its Motion to Quash Third Party Subpoenae by Andrx Corporation, which was filed on August 17, 2000. The response of Andrx Corporation ("Andrx") was due to be filed on September 5, 2000.

This request is made because of the unique and serious issues raised by Andrx's attempt to obtain vital information from Upsher-Smith regarding a product, the generic equivalent of K-Dur, in which Andrx and Upsher-Smith are direct competitors and because Andrx's requests seek documents which are clearly irrelevant under the test of FTC Rule of Practice 3.31 (c) (1). Similar issues are presented in a Motion to Quash filed by Schering-Plough Corporation on August 24, 2000, regarding another Andrx subpoena. Moreover, Andrx has apparently served similar subpoenae on numerous other third parties, so the issues presented by Upsher-Smith's

Motion to Quash will likely have application well beyond the two subpoenae served on Upsher-Smith.
