### MOTION FOR EXTENSION OF TIME TO FILE MOTION TO LIMIT SUBPOENA DUCES TECUM

UNICARE HEALTH PLANS OF THE MIDWEST, INC. ("UNICARE"), by its attorneys, Donald A. Murday, Elizabeth G. Doolin, Michael B. Galibois, and Chittenden, Murday & Novotny LLC, in accordance with the provisions of the Federal Trade Commission Act, and pursuant to Section 3.22 of the Federal Trade Commission Rules of Practice, moves for an extension of time to file its Motion to Limit or Quash Subpoena Duces Tecum and to comply with Section 3.38A. In support of its Motion, UNICARE states as follows:

1. UNICARE is a third-party respondent to discovery. On April 28, 2004, UNICARE received Respondents' Subpoena Duces Tecum ("Subpoena"). The Subpoena contains forty-three (43) requests, exclusive of subparagraphs, which purport to seek a voluminous amount of documents and information. The compliance date indicated on the Subpoena was May 17, 2004.

2. In light of the extensive breadth of information sought in the Subpoena, on May 7, 2004, counsel for UNICARE filed a Motion for an Extension of Time to File a Motion to Limit the Subpoena. While its Motion initially sought an additional thirty (30) days in which to

file its objections to the Subpoena, UNICARE subsequently reduced its request for time to fourteen (14) days from the date UNICARE's Motion to Quash or Limit the Subpoena would have been due (May 10, 2004), or until May 24, 2004. On May 17, 2004, the Court granted UNICARE's Motion, in part, and extended its time to file its objections to the Subpoena by May 24, 2004. A true and correct copy of the Court's Order is attached hereto as Exhibit 1.

3. Counsel for UNICARE reviewed and evaluated the Subpoena and, pursuant to Section 3.22(f), contacted counsel for Respondents on May 20, 2004 to schedule a mutually convenient to time to discuss Respondents' requests and attempt resolve objections that may arise. On May 21, 2004, counsel for Respondents returned the call. Due to time constraints and Respondent counsel's schedule, both parties agree to confer on May 25, 2004. A true and correct copy of counsel's letter confirming the scheduled meeting is attached hereto as <u>Exhibit 2</u>.

4. In order to accommodate its efforts to resolve any discovery disputes with Respondents while maintaining its right to object to the breadth and scope of the Subpoena, UNICARE now seeks an additional four (4) days, or until May 28, 2004, to file its Motion to Quash or Limit the Subpoena and comply with Section 3.38A.

5. This Motion is brought in good faith and will not unnecessarily delay these proceedings or prejudice any of the parties to this Litigation.

WHEREFORE, UNICARE seeks a four (4) day extension of time to file its Motion to Quash or Limit the Subpoena and to comply with Section 3.38A to and including May 28, 2004.


