

**ORDER ON PARTIES' MOTIONS FOR *IN CAMERA* TREATMENT**

**I.**

Pursuant to Commission Rule 3.45(b) and the Scheduling Order entered in this litigation, Complaint Counsel and Respondent Evanston Northwestern Healthcare, Inc. ("ENH") have filed motions for *in camera* treatment of documents that are listed on their exhibit lists as documents that might be introduced at trial in this matter.

In Commission proceedings, requests for *in camera* treatment must show that the public disclosure of the documentary evidence will result in a clearly defined, serious injury to the person or corporation whose records are involved. *In re Kaiser Aluminum & Chem. Corp.*, 103 F.T.C. 500, 500 (1984); *In re H.P. Hood & Sons, Inc.*, 58 F.T.C. 1184, 1188 (1961). That showing can be made by establishing that the documentary evidence is "sufficiently secret and sufficiently material to the applicant's business that disclosure would result in serious competitive injury," and then balancing that factor against the importance of the information in explaining the rationale of Commission decisions. *Kaiser*, 103 F.T.C. at 500; *In re General Foods Corp.*, 95 F.T.C. 352, 355 (1980); *In re Bristol Myers Co.*, 90 F.T.C. 455, 456 (1977).

Indefinite *in camera* treatment is granted only in those "unusual" cases where the competitive sensitivity or the proprietary value of the information will not diminish with the passage of time. *In re Coca-Cola Co.*, 1990 FTC LEXIS 364, at \*6-7 (Oct. 17, 1990). Examples of documents meriting indefinite *in camera* treatment are trade secrets, such as secret formulas, processes, and other secret technical information, and information that is privileged. *See Hood*, 58 F.T.C. at 1189; *In re R.R. Donnelley & Sons Co.*, 1993 FTC LEXIS 32, at \*3 (Feb. 18, 1993); *In re Textron, Inc.*, 1991 FTC LEXIS 135, at \*1 (Apr. 26, 1991). Where *in camera* treatment is granted for ordinary business records, such as business plans, marketing plans, or sales documents, it is typically extended for two to five years. *E.g.*, *In re E.I. Dupont de Nemours &*

Co., 97 F.T.C. 116, 118 (1981); *In re Int'l Ass. of Conf. Interpreters*, 1996 FTC LEXIS 298, \*13-14 (June 26, 1996).

The Federal Trade Commission strongly favors making available to the public the full record of its adjudicative proceedings to permit public evaluation of the fairness of the Commission's work and to provide guidance to persons affected by its actions. *In re Crown Cork & Seal Co., Inc.*, 71 F.T.C. 1714, 1714-15 (1967); *Hood*, 58 F.T.C. at 1186 (“[T]here is a substantial public interest in holding all aspects of adjudicative proceedings, including the evidence adduced therein, open to all interested persons.”). A heavy burden of showing good cause for withholding documents from the public record rests with the party requesting that documents be placed *in camera*. *Hood*, 58 F.T.C. at 1188. Further, requests for indefinite *in camera* treatment must include evidence to justify why the document should be withheld from the public's purview in perpetuity and why the requestor believes the information is likely to remain sensitive or become more sensitive with the passage of time. *See DuPont*, 97 F.T.C. at 117. Thus, in order to sustain the heavy burden for withholding documents from the public record, an affidavit or declaration demonstrating that a document is sufficiently secret and material to the applicant's business that disclosure would result in serious competitive injury is required. *In re North Texas Specialty Physicians*, 2004 FTC LEXIS 109, at \*2-3 (Apr. 23, 2004). The parties and non-parties have been advised of these requirements. Scheduling Order, Additional Provisions, ¶ 16; Protective Order, ¶ 12.

## II.

Complaint Counsel, on February 3, 2005, filed a motion seeking *in camera* treatment for two exhibits, CX 6279 and CX 6282, and withdrawing its initial motion for *in camera* treatment, filed on January 4, 2005. Complaint Counsel seeks *in camera* treatment for a period of five years. There is no opposition to the motion for *in camera* treatment.

Complaint Counsel's motion provides a declaration of Christopher J. Garmon, an economist at the Federal Trade Commission (“Garmon Declaration”). As described by the Garmon Declaration, the exhibits are tables that compile and summarize confidential data including patient demographic, diagnostic, and payment information obtained from a number of non-parties. Complaint Counsel requests *in camera* treatment on behalf of the non-parties whose confidential information is included in the tables.

A review of the declaration in support of the motion and the exhibits reveals that the information sought to be protected meets the standards for *in camera* treatment. Accordingly, Complaint Counsel's motion is **GRANTED**. *In camera* treatment, for a period of five years, to expire on February 1, 2010, is granted to: CX 6279 and CX 6282.

### III.

Respondents, on January 4, 2005, filed a motion seeking *in camera* treatment. On February 3, 2005, Respondents filed a supplemental memorandum on *in camera* treatment and a motion for leave to file the supplemental memorandum. On February 7, 2005, Respondents filed a consent motion for leave to file revised exhibits to the supplemental motion. The motions for leave are **GRANTED**. Respondents' supplemental memorandum limits the number of documents for which *in camera* treatment is sought and requests *in camera* treatment only for the specific pages containing *in camera* material. Respondents seek *in camera* treatment for periods of three, five, or ten years depending on the type of information. There is no opposition to the motion for *in camera* treatment.

Respondents' motion provides declarations of Joseph Golbus, President of Evanston Northwestern Healthcare Group; Kenneth Herlin, partner at Earnst & Young; Jeffrey Hillbrand, Chief Operating Officer at ENH; Thomas Hodges, Executive Vice President, Finance and Treasurer at ENH; Margaret King, Senior Vice President at ENH; David Loveland, Senior Vice President, Corporate Relations at ENH; and Brian Washa, Vice President, Business Services at ENH. As described by the declarations, the information for which *in camera* treatment is sought includes contracts, pricing, and negotiations; a recent financial audit; business strategy documents; financial and cost data; staff performance; and market assessments. The declarations demonstrate that the information for which *in camera* treatment is sought has been maintained as confidential and disclosure of the information would result in a clearly defined, serious injury to Respondents.

A review of the declarations in support of the motion and the documents reveals that the information sought to be protected meets the standards for *in camera* treatment. Accordingly, Respondents' motion is **GRANTED**. *In camera* treatment is granted to the documents in the following table for the time period identified.


