\*EOUSA does not maintain cost figures for the litigation-related expenses incurred by the United States Attorneys' Offices (USAOs) related solely to FOIA litigation. Of this total amount, EOUSA estimates that the USAOs incurred approximately \$1,100,155 in litigation-related expenses. This estimate is based on information provided by DOJ's Civil Division indicating that the USAOs were delegated 215 cases during the fiscal year, an estimate provided by the Office of Information and Privacy that 100 hours per average were spent on each FOIA case, and EOUSA records showing an average hourly salary rate of \$51.17 for non-supervisory Assistant United States Attorneys. The remainder, \$300,000, represents litigation-related expenses incurred by EOUSA's Freedom of Information and Privacy Staff.
