HP2020 Action Awards

Twenty-four new Healthy People 2020 state, tribal and territorial projects have been awarded and will be initiated on June 1, 2011 to be completed by May 31, 2012. A total of 49 eligible proposals were received.

The projects will address Healthy People 2020 from a variety of perspectives. Several awardees will be working to integrate HP2020 with existing plans; others will be holding regional meetings and gathering stakeholder input to set their own prevention priorities. Three of the projects are focusing on new HP2020 topic areas – Genomics and LGBT health. Among the awardees are fourteen states, nine tribal entities and one territory.

I	СТ	CT Dept. Public Health	The Connecticut Department of Public Health will promote cancer genomics best practices through a surveillance reporting feedback program and education intervention. Focus is on diagnosed cancers associated with hereditary breast and ovarian cancer and Lynch Syndrome.
II	N1	New Jersey Department of Health & Senior Services	NJDHSS will launch an internal and external awareness campaign, develop new and cultivate existing partnerships, and enlist multi-sector partners in priority setting for health planning initiatives statewide. The goal is to facilitate the development and implementation of community action plans to prevent the further spread of HIV/AIDS among women living in Georgia.
IV	KY	Kentucky Department for Public Health, Cabinet for Health and Family Services	This project will utilize the MAP-IT framework with stakeholders at state and community levels to mobilize, assess, plan, implement and track Healthy People objectives. Stakeholders /partners will include multidisciplinary and multi-sector representatives. Innovative methods will include use of videoconference meetings and development of a training module with Kentucky specific successes and best practices. Use of this model will promote a quality improvement culture and adherence to national standards. It will also increase integration among programs and address personal, social, economic, and environmental determinants of health at community levels.

This concept builds upon ODH's existing structure for statewide immunization data collection and reporting through the Ohio statewide immunization management system, IMPACTSIIS, administered by the ODH Division of Prevention.

The SHA also will reflect and link to the 42 HP2020 topics using Minnesota-specific data.
