#### **Director's Corner**

CONGRATULATIONS & THANK YOU! May I, 2011 marks the two year anniversary of the GSA Alliant GWAC Notice to Proceed and words cannot express just how appreciative we are on the support received from our customers and the 58 Alliant primes and their respective teaming partners for making Alliant so successful in such a short time.

"Viral" is the word that Mimi Bruce (GWAC Director of Client Support) used to describe the current state of Alliant in a recent article that appeared in the Federal Computer Weekly (FCW). When looking at the growth of the Alliant GWAC in two short years, there is no question that Alliant is becoming a popular contract for Information Technology (IT) services and the diversity of those clients that have used Alliant; and interest in Alliant has spread quickly.

A comparison of the first five months to where Alliant is today is provided on page 6 of this newsletter. In addition to the increased usage of Alliant, the following are current developments:

- U.S. Department of State The U.S. Department of State selected Alliant to award a ten year \$2.5 Billion Task Order (T.O.) to consolidate and strengthen their critical information by designing, operating, maintaining, and securing their enterprise IT infrastructures and ensuring that security remain a high priority for their global network that connects the department's offices throughout the world.
- Department of Navy (DON) The Department of Navy recently has identified Alliant and Alliant Small Business as candidates for the Navy's Strategic Sourcing initiative aimed at reducing costs, increasing competition and streamlining the acquisition of IT services. This policy would encourage Navy acquisition personnel to use Alliant and Alliant SB, along with the service's own Navy SeaPort-e contract, rather than creating redundant contracts, when acquiring IT services.
- Cloud Computing GSA becomes the first federal agency to move its email system to the cloud, leveraging the Alliant GWAC to award a \$6.7M Task Order (T.O.) that is expected to result in \$15M in savings using shared infrastructure set aside exclusively for government users in a private community cloud (see article on page 4).
- Smart Building Technology GSA's Public Building Service (PBS) is planning on using the Alliant GWAC for its innovative Smart Building program. PBS will be retrofitting 50 of its buildings with technologies that will measure and analyze energy usage to help manage the buildings more efficiently. In addition to improving energy efficiency, Smart Building technologies will enhance the operational effectiveness of the buildings and occupant satisfaction.

Alliant is being utilized by agencies to assist them perform their respective missions and meet their integrated IT services requirements. Alliant's comprehensiveness (anything IT, anywhere) and flexibility (all contract types allowed and alignment with Federal Enterprise Architecture (FEA) and Department of Defense Enterprise Architecture (DODEA)) makes Alliant truly a very unique and remarkable contract. Adding to the mix, a pool of premier Industry Primes that deliver cost effective quality solutions, it is no wonder why Alliant has been so successful in its first two years.

We realize that there are choices that exist in the market place and will continue to explore new and innovative ways that we can provide value added service to you, our valued Alliant customers, as Paul Martin, the GWAC Contracting Officer, provides a sneak peak to in his article on page 2. Thanks again for making the first two years great. Here's hoping for another stellar year ahead.

### **New Alliant Procuring Contracting Officer**



Effective April 1, 2011, the new Alliant Procuring Contracting Officer (PCO) is Mr. John Cavadias. John will be supported by the Administrative Contracting Officer Mr. Roger Chapin and the Contracting

Officer's Technical Representative Ms. Lori Prussing.

The installation of these new employees to the Alliant Program reinforces our commitment to contract and customer excellence. Since the kickoff of Alliant back in May 2009, the Alliant growth has been extremely positive at \$6.1 billion estimated total value awarded and 138 Orders issued under Alliant. This was all possible from a committed staff reaffirming that the Alliant GWAC was, and is, the best integrated information technology contract vehicle for the Federal Government today and for the future. We anticipate that Alliant will see greater demand; therefore we increased our re-

sources in anticipation of the demand. Our initiatives include ongoing training for new Contractor Program Managers/Contract Administrators to help them navigate through this large and complex contract in the quickest timeframe possible, and a renewed focus on competitive pricing. ### Legislative Actions Affecting Multiple Award Contracts

For your awareness, the following highlights key legislative actions affecting multiple award contracts and the underlying task orders:

#### **Expanding FAR 51 Use of Government Sources by Contractors**

To better meet the needs of GSA's customer agencies, a class deviation to FAR Part 51.1 has been approved to expand the authority of contractors to use GSA sources of supply for cost reimbursement contracts to now include T&M /LH contracts in the performance of federal contracts. For GWACs this means Prime Contractors who currently have the authority to use GSA schedules for cost reimbursement efforts will now have the expanded authority to use GSA schedules for T&M/LH efforts in support of GWAC task orders.

# Proposed Legislation Extends Sunset on Task Order Protests to September 30, 2016, for DOD Agencies; Civilian Agencies Pending

GAO's protest authority was established for both defense and civilian agencies under FY 2008 NDAA (Public Law 110-181). The FY 2011 NDAA (Public Law 111-383) extended GAO's jurisdiction over Department of Defense component through September 30, 2016 but its authority over these protests at civilian agencies expires on May 27, 2011. Companion legislation for civilian parity has been introduced into the House and Senate via H.R. 899 and S. 498 and is pending resolution.

#### Publishing Non Competitive Actions in FedBizOpps

FAC 2005-50 amends the FAR to implement section 863 of the Duncan Hunter National Defense Authorization Act for Fiscal Year 2009 (Pub. L. 110-417). Section 863 mandates enhanced competition for orders placed under multiple-award contracts, including Federal Supply Schedules. If an order over the simplified acquisition threshold does not follow the section 863 competitive procedures, section 863 requires that a notice and the determination of an exception be published in FedBizOpps within 14 days after award. This interim rule is effective May 16, 2011, and applies to solicitations issued and contracts awarded on or after that date, including orders issued on or after May 16, 2011 under previously awarded underlying contracts and blanket purchase agreements.

#### Guidance on Subcontracts under Alliant

Contractors proposing subcontracts under Alliant are required to comply with Federal Acquisition Regulation (FAR) Subpart 44.2—Consent to Subcontracts and FAR Clause 52.244-2—Subcontracts. Accordingly, the Alliant Delegation Procurement Authority (DPA) delegates the responsibility of subcontract consent to the Ordering Contracting Officers (OCOs). OCOs planning to solicit information technology services and contemplating the use of subcontractors under the Alliant Governmentwide Acquisition Contract (GWAC) are advised to request documentation regarding the current approval status of the offeror's purchasing systems.

If the Alliant contractor does not have an approved purchasing system, the OCO consent to subcontract is "required" for all contract types, except for fixed price and for fixed price contracts that have limiting conditions specified in FAR Subpart 44.2.

Even if the Alliant contractor has an approved purchasing system, OCOs may still request identification of subcontractors by requiring the Alliant contractor to list subcontractor names in the fill-in portion of FAR Clause 52.244-2.

As part of the OCO's due diligence in reviewing proposed subcontractors, check the business size of the subcontractors, check whether the subcontractors have a satisfactory record of performance; and ensure that the subcontractors are not on the Excluded Parties List System.

### Alliant Program Management Review, January 24, 2011, San Diego, CA

The Enterprise GWAC Center held the Alliant Program Management Review (PMR) on January 24th at the San Diego Convention Center in San Diego, CA. The PMR included various speakers including Michael Canales, DoD Defense Procurement and Acquisition Policy; Gary Wang, Chief Operations Officer, Corporate Operations, Space and Naval Warfare Systems Command; Former GSA Senior Executives, John Johnson, Robert Woods, and Charlie Self; and a report out by the industry Shared Interest Groups (SIGs). For the first time at an Alliant PMR, FEDSIM provided an update on the upcoming billion dollar St. Elizabeth's procurement that will be recompeted under Alliant. Mimi Bruce and Richard Blake presented "GSA's Next Generation GWACs" at AFCEA West Conference in San Diego, CA the week of January 25<sup>th</sup>, 2011. The GWAC team attended the Dept of Navy Strategic Sourcing Presentation. The DON Strategic Sourcing Team has officially recognized that the use of Alliant and Alliant Small Business are viable contractual vehicles that can be utilized to meet strategic sourcing initiatives. Mimi Bruce and Richard Blake also gave the "Next Generation GWAC" presentation to an audience of Industry. The presentation was expanded to include a new look and feel in our IT and Scope slides through incorporation of new and emerging IT trends and technologies. This new emphasis provided a better understanding to the FEA/DODEA scope. Our new revised presentation was well received and the concept was expanded for GSA Expo.

#### Alliant Program Management Review, April 6, 2011, Atlanta, GA

The Alliant Program Management Review (PMR) was hosted by FAS Assisted Acquisition Service / Customer Account Representatives Region 4 on April 6<sup>th</sup> at the Melia Hotel in Atlanta, GA. # Cloud-Breaking News for GSA Email & Collaboration

GSA is preparing to launch a new email and collaboration system, Google Apps for Government, designed to enable a new level of interaction and mobility. Unisys is proud of our prime contractor role in helping GSA make its historic, enterprise-wide move to the cloud – a first for a major federal agency. This work is being delivered via a five-



year, \$6.7-million Alliant GWAC task order. The GSA OCIO, working with GSA Federal Acquisition Service, took advantage of the innovative BetterBuy project to seek industry input during the RFI stage of the process. GSA sought industry input on the overall procurement strategy, as well as the requirements themselves. Based on the RFI responses, GSA made the decision to use the Alliant contract, providing a flexible approach to solution development by the bidders. The Alliant contract provides the means to successfully deliver new cloud services that will continue to evolve over time.

Up to 17,000 GSA employees and contractors worldwide will benefit from enhanced collaboration services using the Google Apps suite including: Gmail; GCalendar, Docs and Sites and Groups. Additionally, because of Google's continuous innovation philosophy, where new features and capabilities are made available on an ongoing basis, users always have access to the latest state-of-the-art technology. In addition to Google, the Unisys team includes Tempus Nova, Inc., and Acumen Solutions.

The migration of e-mail services to off-site data centers is expected to result in at least \$15m in savings over the next five years when compared to current staff, infrastructure and contract support costs, according to GSA estimates. "Cloud computing has a demonstrated track record of cost savings and efficiencies," Casey Coleman, GSA's chief information officer, said. "The benefit to GSA employees will be a modern, robust e-mail and collaboration platform that better supports our mission and our mobile workforce, and costs half as much."


