Executive summary

This quarter, the OERC created proposals and plans for several major evaluation projects involving multiple regions:

NN/LM Emergency Preparedness Initiative: After discussions with NNO and the Emergency Preparedness Coordinator, the OERC drafted a plan for additional evaluation activities for the NN/LM Emergency Preparedness Initiative and prepared to present the plan at the RML Directors' Meeting in May. This evaluation will involve all 8 regions.

Adobe Use by RML Staff: Following several planning discussions with the National Network Office and the Evaluation Liaisons group, the OERC developed a plan for evaluating Adobe Connect use by RML staff and prepared to present it at the RML Directors' Meeting in May. The OERC is undertaking this assessment upon request from NNO. This evaluation will involve all 8 regions.

<u>Community Day</u>: Upon request from NNO the OERC worked with Lisa Boyd and regions 2,5, and 8 to design an evaluation plan for the Community Day pilot projects that are being conducted in those three regions.

Dissemination of effective practices

The Outreach Connections: Native Health Information portal is a nascent collection of effective practices for health information outreach to native communities. Now that its construction is completed, the publicity efforts led by Susan Barnes are becoming a primary focus of activity.

The Planning and Evaluating Health Information Outreach booklet series was designed to present effective evaluation practices. The booklets are distributed in paper form by the OERC in classes and upon request. Seventeen printed sets of the booklets, plus seventeen printed copies of the *Measuring the Difference* guide, were distributed this quarter. The booklets are also available full text in pdf form on the OERC web site. Google Analytics reports for the nnlm.gov site show significant use of these online booklets.

I. Develop awareness, skill, and capacity in use of evaluation methods.

The OERC provided two Adobe Connect sessions this quarter: one on Logic Models for the NLM Associate Fellows, and the "Clever Evaluation" session for NN/LM SCR. Susan Barnes taught the "Data Collection" class at the Washington Medical Librarians Association annual meeting.

II. Develop mechanisms to disseminate and use evaluation findings to help NLM and the NN/LM document and demonstrate their accomplishments

Outreach Connections: Native Health Information: Susan Barnes continued to serve as chair of the Publicity/Evaluation Subcommittee as it distributed information about the portal at various events. During this quarter, the subcommittee led focused discussions to learn about the collaboration that created this portal. Questions for these discussions were based on the New York Academy of Medicine's Partnership Self-Assessment Tool. Fifteen collaboration participants contributed their insights in four Adobe-Connect based focused discussions.

III. Strengthen and build an evaluation culture throughout NN/LM.

Evaluation Liaisons:

The OERC led three evaluation liaison teleconferences this quarter. The first, in February, was an initial step in the study of Adobe Connect use by RMLs: we discussed what questions should be asked and who should be asked. The second, in March, was an opportunity for the OERC to provide an overview to the evaluation liaisons of the various upcoming evaluation activities, including Adobe Connect use by RMLs, additional evaluation of the National Emergency Preparedness and Response Initiative, evaluation of the Community Day pilot projects, and focused discussions with Outreach Connections steering committee members. In the third, Cindy provided information about followup studies that the OERC is conducting with participants in the Measuring Your Impact: Using Evaluation for Library Advocacy class and in the Outreach Evaluation Series classes.

Evaluation:

As mentioned above, the OERC is conducting followup studies with participants from the Measuring Your Impact session. Cindy sends questionnaires to participants approximately six months after classes take place to collect information about whether, and how, information from the classes has been used.

VI. Provide consultation and direction in implementing evaluation systems, structures, and resources to help the NN/LM's efficacy and efficiency.
