SUBJECT: Supplemental Nutrition Assistance Program (SNAP) – Fiscal Year (FY) 2012
Cost-of-Living Adjustments (COLAS)

TO: All Regional Directors
Supplemental Nutrition Assistance Program

Attached are the FY 2012 Cost-of-Living Adjustments (COLAS) to the SNAP income eligibility standards and deductions for the 48 contiguous States and D.C., Alaska, Hawaii, Guam, and U.S. Virgin Islands. Under the American Recovery and Reinvestment Act of 2009 (ARRA), the maximum and minimum allotments remain unchanged for the continental United States and the District of Columbia for FY 2012. ARRA raised the maximum SNAP allotments by 13.6 percent of the June 2008 value of the Thrifty Food Plan (TFP) and provided that benefits could not fall below this level. Although final data for Alaska and Hawaii have yet to be released, the Food and Nutrition Service (FNS) anticipates that the maximum and minimum allotments will also remain unchanged for FY 2012 due to ARRA. Should adjustments become necessary once final data is released, FNS will issue revised numbers for these areas.

By maintaining the maximum allotment of \$668 for a household size of four, ARRA continues to protect SNAP recipients from any erosion in purchasing power. In the absence of ARRA, the maximum allotment for a 4-person household would have been \$611 for FY 2012. Thus, ARRA resulted in an overall increase of \$57 in SNAP benefits, allowing eligible households to purchase more nutritious food.

The shelter cap values for FY 2012 increased slightly to \$459 for the 48 States and DC. Alaska, Hawaii, Guam and the U.S. Virgin Islands also had minimal increases in their shelter cap values. The minimum standard deduction for household sizes 1 through 3 increased from \$142 to \$147 a month for the 48 States and DC. Alaska, Hawaii, Guam, and the U.S. Virgin Islands also experienced increases in their standard deduction amounts.
