Sandra Lahi 837, third party billing, p4 – was released on 12-12-03 and needs to be installed by sites that are now ready to test the 837 format. 3P Patch4 was not able to finalize Trailblazer, Part A & B and NM Medicaid. AZ-AHCCCS certified 3P Patch 4 and sites who will be submitting to AHCCCS will have to have Patch 4 installed first. ITSC is working with area coordinators to get rollout plan for sites.
If you have tribal sites billing to UGS Medicare FI, let Susan Bowman know and Susan can assist with providing guidance on how to get you set up to start testing.
835. Still testing AR Patch 4. It currently has been tested for the

Trailblazers Part A and B 835 format. The AR Standard Adjustment and Reason Codes have also been revised by replacing the pending categories to the Nonpayment categories. This was done at the request of the TAG membership. AR Patch 4 did not include the PNC bank testing module as there was a delay in getting the PNC bank side of things setup. Part A Medicare tested at Tuba City, Sells and Kayenta.

270/271, Pt. Reg., P2 did not include the 270/271 development due to lack of testing partners. Plans are for Patch 3 to include this development. CMI has to finish testing the GIS patch for the 270/271 transaction. Cimarron is working on it.

ITSC needs test sites. Please contact Susan, Carl, Adrian or Sandra if you have any sites that can start testing.
