23	Plaintiff, the Federal Trade Commission ("FTC" or "Commission"), through	
24	its undersigned attorneys, for its Complaint alleges:	
25	1. The FTC brings this action under Section 13(b) of the Federal Trade	
26	Commission Act ("FTC Act"), 15 U.S.C. § 53(b), to secure a permanent	
27	injunction, restitution, disgorgement, and other equitable relief against Defendants	
28	for engaging in deceptive acts or practices and false advertising in connection with	

the advertising, marketing, and sale of products purporting to treat, prevent, and or cure such conditions as cancer, diabetes, Alzheimer's disease, inflammatory bowel disease, and other serious medical illnesses, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

## JURISDICTION AND VENUE

- 2. This Court has jurisdiction over this matter pursuant to 15 U.S.C. §§ 45(a), 52, and 53(b) and 28 U.S.C. §§ 1331, 1337(a), and 1345.
- 3. Venue in this District is proper under 15 U.S.C. § 53(b) and 28 U.S.C. §§ 1391(b) and (c).

## **PLAINTIFF**

4. Plaintiff FTC is an independent agency of the United States Government created by statute. 15 U.S.C. §§ 41-58. The Commission enforces Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), which prohibits unfair or deceptive acts or practices in or affecting commerce. The Commission also enforces Section 12 of the FTC Act, 15 U.S.C. § 52, which prohibits false advertisements for food, drugs, devices, services, or cosmetics in or affecting commerce. The Commission, through its own attorneys, may initiate federal district court proceedings to enjoin violations of the FTC Act and to secure such equitable relief, including rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of ill-gotten monies, as may be appropriate in each case. 15 U.S.C. § 53(b).

#### **DEFENDANTS**

5. Defendant 7 Day Marketing, Inc. ("7DMI") is a California corporation with offices located at 7271 Paramount Blvd., Pico Rivera, CA 90660. 7 Day Marketing, Inc. advertises, markets, offers for sale, and sells the 7 Day Miracle Cleanse program. 7DMI is headquartered and has its principal place of business in the Central District of California and transacts or has transacted business in this district and throughout the United States.

6. Defendant Anthony Paris DeAguero ("Paris DeAguero") is a 50 percent owner and member of the Board of Directors of Defendant 7DMI. He is also the originator of the 7 Day Miracle Cleanse program and is responsible for managing the marketing and intellectual property of the products marketed as part of the 7 Day Miracle Cleanse program. Defendant Paris DeAguero also owned, managed, and controlled 7 Day Miracle Cleanse ("7DMC"), a fictitious business name registered and owned by Defendants Paris DeAguero and Laura DeAguero and used to conduct business prior to the incorporation of Defendant 7DMI. During the times relevant to this Complaint, Defendant Paris DeAguero resided in the Central District of California. At all times relevant to this Complaint, acting individually and in concert with others, Defendant Paris DeAguero formulated, directed, controlled, or participated in the policies, acts, or practices of Defendant 7DMI. He transacts or has transacted business in this district and throughout the United States.

- 7. Defendant Dieter Ammann is a 50 percent owner of Defendant 7 Day Marketing, Inc. He is also the President and Chief Executive Officer of the company. Defendant Dieter Ammann resides in the Central District of California. At all times relevant to this Complaint, acting individually and in concert with others, Defendant Dieter Ammann formulated, directed, controlled, or participated in the policies, acts, or practices of Defendant 7 Day Marketing, Inc. He transacts or has transacted business in this district and throughout the United States.
- 8. Defendant Laura DeAguero is a former employee of Defendant 7 Day Marketing, Inc. Her responsibilities included conducting purported scientific research for the company. Defendant Laura DeAguero also owned, managed and controlled 7DMC, a fictitious business name registered and owned by Defendants Anthony Paris DeAguero and Laura DeAguero and used to conduct business prior to the incorporation of Defendant 7DMI. At times relevant to this Complaint, Defendant Laura DeAguero formulated, directed, controlled, or participated in the

policies, acts, or practices of Defendant 7 Day Marketing, Inc. and its predecessor companies. She transacts or has transacted business in this district and throughout the United States.

## **COMMERCE**

9. The acts and practices of Defendants alleged in this complaint are and have been in or affecting commerce, as "commerce" is defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

## **DEFENDANTS' COURSE OF CONDUCT**

- 10. During January 2003 through December 2005, Defendants Anthony Paris DeAguero, Laura DeAguero, and Dieter Ammann engaged in the advertising, promotion, offering for sale, sale, and distribution of the 7 Day Miracle Cleanse program to consumers located throughout the United States. The 7 Day Miracle Cleanse program was advertised, promoted, offered for sale, sold, and distributed by various means, including through a 30-minute nationally disseminated infomercial and through the Internet, including but not limited to the website www.7dmc.com.
- 11. Since at least December 2005, Defendants 7DMI, Anthony Paris DeAguero, Dieter Ammann, and Laura DeAguero engaged in the advertising, promotion, offering for sale, sale, and distribution of the 7 Day Miracle Cleanse program to consumers located throughout the United States. These Defendants advertise and offer the 7 Day Miracle Cleanse program for sale through a 30-minute nationally disseminated infomercial and through the Internet, including but not limited to the websites www.7dmc.com and www.7dmi.com.
- 12. The 7 Day Miracle Cleanse program purportedly makes users immune to all illness and prevents, treats, and cures all types of serious diseases, including cancer, Alzheimer's disease, diabetes, fibroid tumors, high blood pressure, irritable bowel syndrome, and other forms of gastrointestinal disease. The program consists of three products, all of which are combinations of herbs and other ingredients.

Herbal Mucous Eliminator contains ingredients such as cascara sagrada, bentonite clay, buckthorne bark, flax seeds, aloe vera, senna leaf, and slippery elm. Consumers are instructed to take seven capsules in the morning and in the evening for seven days. Super Boost Greens contains ingredients such as gotu kola, spirulina, alfalfa, wheat grass, kelp, and kale. (A previous formulation contained spinach rather than kale, but was otherwise identical in formulation.) Consumers are instructed to take three to six capsules daily. Continued use is recommended even after completing the program. Parasine 2 contains ingredients such as wormwood, senna pods, black seeds, green black walnut hulls, pumpkin seeds, and bioperine extract. Consumers are instructed to take ten capsules before bedtime for ten days. The cost to consumers for the 7 Day Miracle Cleanse one-week starter program is approximately \$89.95 to \$99.95, plus shipping fees.

13. To induce consumers to purchase the 7 Day Miracle Cleanse program, the Defendants disseminated or caused to be disseminated advertisements, including but not limited to the Attached Exhibits A through D. These advertisements contain, among other things, the following statements and depictions:

## **EXCERPTS FROM INFOMERCIAL: EXHIBIT A**

a. THE HEALTH MAN: Are you sick and tired of being sick and tired? Are you one of millions who suffer from the common ailments such as constipation, irritable bowel syndrome, fatigue, Alzheimer's and other diseases? Have you been struggling year in and year out with your health problems? Then why should you suffer anymore?

I have the solution for you. Imagine being in control of your health. You can look and feel 10 to 20 years younger than your age, have perfect cholesterol, perfect body weight and consistent bowel eliminations, a body immune to all sickness. These are the characteristics of perfect health.

THE HEALTH MAN: In the next half-hour, I guarantee each and every one of you that you will be amazed as I show you the most innovative health rejuvenation system in the world, which has never been available to the public until now. [Exhibit A at 4-5 (Statements scrolling at top of screen omitted).]

- b. THE HEALTH MAN: For example, the major colon disease, diverticulosis increased from 10 percent of adults over the age of 45 in 1950 to 50 percent by 1987. The most recent edition [of the Merck Manual] declares that virtually every American adult will have diverticulosis in the large intestines at some point in their life. This can be prevented. [Exhibit A at 6-7 (Statements scrolling at top of screen omitted).]
- c. THE HEALTH MAN: Now, this should surprise many of you. Did you know that your digestive tract is responsible for about 90 percent of your overall health? Yes, 90 percent. [Exhibit A at 10 (Statements scrolling at top of screen omitted).]
- d. THE HEALTH MAN: Mucous plaque creates a daily self-poisoning effect on your entire body called toxemia. This mucous plaque exists inside of almost every American and lines the internal wall of your colon.

We have the ability to live twice as long as we are living today, but we need the knowledge of how to do this. The colon is one of the primary indicators as to how long we will live.

The average person will lose 10 to 25 pounds or more in just seven days. [Exhibit A at 16 (Statements scrolling at top of screen omitted).]
- f. THE HEALTH MAN: Another danger of mucous plaque is that it houses toxins, such as heavy metals, which is thought to be a major contributor of Alzheimer's Disease. It also houses parasites, fungi, worms and harmful bacteria, each of which can weaken your immune system. The elimination of this filth is one of the key components in achieving perfect health and in building a pain-free body for both young and old.

I challenge any person, any organization to prove me wrong.

What I am talking about is real. It's never too late to benefit from the

Seven Day Miracle Cleanse Program, a rejuvenation system.

ON SCREEN: These statements have not been evaluated by the Food and Drug Administration and are the opinions of the speaker. This product is not intended to diagnose, treat, cure, or prevent any disease.

I had been living with open sores on my body that would never scab or heal. Then a lump developed in the right pectoral area of my chest. It grew to the size of a golf ball. - j. MALE ANNOUNCER: As you consume acid-forming foods, your blood's pH level is adversely affected. Your blood will automatically leach minerals from your bones and muscles. Our bones can become brittle and shrink as our muscles lose their tone as we get older. The Super Boost Greens can replenish these minerals. [Exhibit A at 30 (Statements scrolling at top of screen omitted).]
- k. THE HEALTH MAN: How much do you value your health? How much would it be worth to prevent degenerative health problems so you don't find yourself on the surgeon's table under the knife? Would you pay a million dollars, a \$100,000, \$10,000?

At this moment, I offer you the opportunity to take charge of your health.

ON SCREEN: These statements have not been evaluated by the Food and Drug Administration and are the opinions of the speaker. This product is not intended to diagnose, treat, cure, or prevent any disease.

THE HEALTH MAN: Celebrities pay as much as \$5,000 for this identical program, but your cost is less than one visit to a doctor at only \$89 plus shipping and it comes with a money back guarantee. [Exhibit A at 35 (Statements scrolling at top of screen omitted).]

- 1. THE HEALTH MAN: The Seven Day Miracle Cleanse really works.

  There is no need to wait for a flat stomach any longer. [Exhibit A at

  36 (Statements scrolling at top of screen omitted).]
- m. THE HEALTH MAN: How many of you women suffer every month with bloating, cramps and other symptoms of PMS? Women who have completed just one seven-day program and add fresh vegetable juices to their diet state that PMS is a thing of the past. Isn't this something that you could get really excited about or do you like feeling terrible every month? [Exhibit A at 38 (Statements scrolling at top of screen omitted).]
- n. THE HEALTH MAN: The key to losing weight is in balancing the thyroid gland in your body because it controls the production of fat cells. Men and women spend billions of dollars each year for a hope or a diet that will cure all their problems in achieving their ideal weight. There is no better system than the Seven Day Miracle Cleanse for losing weight faster, healthier and more naturally, without harmful chemicals or side effects. The average person will lose 10 to 25 pounds or more in just seven days. [Exhibit A at 38 (Statements scrolling at top of screen omitted).]

- 1. "I feel better than I have in a long time and I only just started the program My blood pressure is now normal without need for medication after years of doctoring." G King Spokane WA [Exhibit D at 7DMC-00062.]
- Attack *the cause*, not the symptom . . . m. Your body contains almost all the resources it needs to fight off any disease or sickness if it is unencumbered by the things that slow it

down or cause it to function erratically. If you attack the cause of the problem, instead of the symptom (e.g. surgically removing a tumor attacks a symptom) then the body's own healing and balancing systems can do their job to the fullest to regulate and to metabolize body weight, heal and prevent major and minor illnesses and restore vitality. . . . Artificial, quick cures, including pills and surgery don't get to the root of the cause, [sic] The 7-Day Miracle Cleanse attacks the cause of most sickness and disease by removing the hardened, rubber-like, mucus layers which promote sluggish muscle tone and the inability of the large intestine (colon) to eliminate properly. Attacking this pollution and congestion allows the body to begin its own . . . SELF HEALING. [Exhibit D at 7DMC-00067.]

n. Parasites thrive on an unhealthy intestinal tract. Mucus is a perfect breeding ground for parasites. It has been estimated that over 90% of the population of the U.S. is infested with parasites. Over 50 million children have worms. . . . Many health problems start with worms and parasites colonizing throughout the digestive tract and vital organs. The most common symptoms are lack of energy, bowel problems, chills, fever, and even epilepsy. The 7 Day Miracle Cleanse<sup>TM</sup> begins the removal of this breeding ground by removing their ideal environment of mucus and filth in the intestinal tract. [Exhibit D at 7DMC-00070.]

## EXCERPTS FROM HANDBOOK INCLUDED WITH PACKAGING

a. PREVENTING/FIGHTING ALZHEIMER'S DISEASE

According to Dr. Philip Hodes, there are steps everyone can take to prevent or treat Alzheimer's disease:

\* \* \* \* \* \*

- 2. Undergo a brain and body detoxification program, which includes a fast. . . . This step precisely describes the 7-Day Miracle Cleanse, a professional detoxification program useful in preventing or treating Alzheimer's disease. [Exhibit E at pp. 22-23.]
- b. It is estimated that 80 to 92% of the population suffer from parasites and don't know it.

\* \* \* \* \*

Over time, they can grow bigger or multiply rapidly and rob you of the abundance of nutrients from your body. This may sound alarming but it is reality. The answer to the question of how to get rid of these parasites is by taking a clinically proven herbal combination called Parasine 2 and following it with the 7-Day Miracle Cleanse Program. [Exhibit E at p. 24.]

## **SECTIONS 5 AND 12 OF THE FTC ACT**

14. Section 5(a) of the FTC Act, 15 U.S.C. § 45(a), prohibits unfair or deceptive acts or practices in or affecting commerce. Section 12(a) of the FTC Act, 15 U.S.C. § 52(a), prohibits the dissemination of any false advertisement in or affecting commerce for the purpose of inducing, or which is likely to induce, the purchase of food, drugs, devices, services, or cosmetics. For the purposes of Section 12 of the FTC Act, the products distributed in the 7 Day Miracle Cleanse program are either "foods" or "drugs" as defined in Section 15(b) and (c) of the FTC Act, 15 U.S.C. § 55(b) and (c). As set forth below, the Defendants have engaged and are continuing to engage in such unlawful practices in connection with the marketing and sale of the 7 Day Miracle Cleanse program.

## DECEPTIVE ACTS OR PRACTICES IN VIOLATION OF THE FTC ACT

- 15. Through the means described in Paragraph 13, including but not limited to the statements contained in the advertisements attached as Exhibits A through E, Defendants have represented, expressly or by implication, that:a. The 7 Day Miracle Cleanse program prevents, treats, and cures breast
  - cancer, skin cancer, and all other types of cancer;
  - b. The 7 Day Miracle Cleanse program prevents and treats Alzheimer's disease;
  - c. The 7 Day Miracle Cleanse program prevents, treats, and cures diabetes;
  - d. The 7 Day Miracle Cleanse program prevents, treats, and cures AIDS;
  - e. The 7 Day Miracle Cleanse program prevents, treats, and cures high blood pressure;
  - f. The 7 Day Miracle Cleanse program prevents, treats, and cures migraine headaches;
  - g. The 7 Day Miracle Cleanse program prevents, treats, and cures fibroid tumors;
  - h. The 7 Day Miracle Cleanse program prevents, treats, and cures premenstrual syndrome;
  - i. The 7 Day Miracle Cleanse program prevents, treats, and cures endometriosis;
  - j. The 7 Day Miracle Cleanse program prevents, treats, and cures diverticulitis, irritable bowel syndrome, and all other types of bowel dysfunction;
  - k. The 7 Day Miracle Cleanse program prevents, treats, and cures arthritis;

- 1. The 7 Day Miracle Cleanse program causes rapid and substantial weight loss safely and without side effects;
- m. The average user of the 7 Day Miracle Cleanse program will lose 10 to 25 pounds or more in just seven days;
- n. The 7 Day Miracle Cleanse program has caused weight loss of as much as 41 pounds in seven days and 128 pounds in four months;
- o. Parasine 2 is clinically proven to eliminate parasites and worms, including tapeworms; and
- p. Super Boost Greens prevents bones from becoming brittle and shrinking.
- 16. The representations set forth in Paragraph 15 are false or were not substantiated at the time they were made. Therefore, the making of the representations set forth in Paragraph 15 constitutes a deceptive practice, and the making of false advertisements, in or affecting commerce, in violation of Sections 5(a) and 12 of the FTC Act, 15 U.S.C. §§ 45(a) and 52.

#### **INJURY**

17. Consumers throughout the United States have suffered and continue to suffer substantial monetary loss as a result of Defendants' unlawful acts or practices. In addition, Defendants have been unjustly enriched as a result of their unlawful practices. Absent injunctive relief by this Court, Defendants are likely to continue to injure consumers, reap unjust enrichment, and harm the public interest.

## THIS COURT'S POWER TO GRANT RELIEF

18. Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), empowers this Court to grant injunctive and such other relief as the Court may deem appropriate to halt and redress violations of the FTC Act. The Court, in the exercise of its equitable jurisdiction, may award other ancillary relief, including, but not limited to, rescission or reformation of contracts, restitution, the refund of monies paid,

and the disgorgement of ill-gotten monies caused by Defendants' law violations.

## PRAYER FOR RELIEF

Wherefore, Plaintiff Federal Trade Commission, pursuant Section 13(b) of the FTC Act, 15 U.S.C. § 53(b), and the Court's own equitable powers, requests that the Court:

- Enter a permanent injunction to prevent future violations of the FTC (1) Act by the Defendants;
- (2) Award such relief as the Court finds necessary to redress injury to consumers resulting from Defendants' violations of the FTC Act, including, but not limited to, rescission or reformation of contracts, restitution, the refund of monies paid, and the disgorgement of illgotten monies; and
- (3) Award Plaintiff the costs of bringing this action, as well as such other and additional relief as the Court may determine to be just and proper.
