TREASURY INTERNATIONAL CAPITAL DATA FOR APRIL

Treasury International Capital (TIC) data for April are released today and posted on the U.S. Treasury web site (www.treas.gov/tic). The next release date, which will report on data for May, is scheduled for July 18, 2006.

Net foreign purchases of long-term securities were \$46.7 billion.

- Net foreign purchases of long-term domestic securities were \$58.5 billion, \$21.3 billion of which were net purchases by foreign official institutions and \$37.2 billion of which were net purchases by private foreign investors.
- U.S. residents purchased a net \$11.9 billion in foreign issued securities.
