NIGC Announces Tribal Consultation Dates for New Strategic Plan and Draft Consultation Policy

Washington, DC August 23, 2012 — The National Indian Gaming Commission (NIGC/Commission) announced today that it has scheduled four consultations to introduce the draft FY 2014-18 NIGC Strategic Plan and draft consultation policy.

Every four years NIGC is required to update the Agency's Strategic Plan. The Commission is seeking meaningful input on the NIGC draft Strategic Plan, which provides a concrete basis for establishing strategic goals and strategies by which the agency will achieve those goals.

In addition, the Commission continues to evaluate its draft consultation policy. The Commission requests tribal comments regarding its current consultation practice and draft consultation policy.

Copies of both the draft FY 2014-18 Strategic Plan and draft consultation policy will be available September 4, 2012, which the NIGC will distribute to tribes and the public shortly thereafter.

The Commission invites all tribal leaders and their designees to share their views with the Commission during the following scheduled consultations, which will focus solely on the draft Strategic Plan and consultation policy:
