

# Department of Defense **INSTRUCTION**

NUMBER 4140.58 January 8, 2010

SUBJECT: National Guard and Reserve Equipment Report (NGRER)

References: See Enclosure 1

1. PURPOSE. This Instruction:

a. Reissues DoD Directive (DoDD) 4140.58 (Reference (a)) as an Instruction in accordance with the authority in DoDD 5124.02 (Reference (b)) to update policy and responsibilities for preparing and submitting the NGRER to the Congress on Reserve Component (RC) equipment in accordance with section 10541 of title 10, United States Code (Reference (c)).

b. Reiterates policy and assigns responsibilities associated with equipping the RCs.

c. Incorporates new reporting requirements directed in Public Law 110-181 (Reference (d)).

2. <u>APPLICABILITY</u>. This Instruction applies to OSD, the Military Departments (including the Coast Guard at all times, including when it is a Service in the Department of Homeland Security by agreement with that Department), the Office of the Chairman of the Joint Chiefs of Staff and the Joint Staff, the Combatant Commands, the Office of the Inspector General of the Department of Defense, the Defense Agencies, the DoD Field Activities, the National Guard Bureau, and all other organizational entities within the Department of Defense.

3. <u>DEFINITIONS</u>. See Glossary.

4. <u>POLICY</u>. It is DoD policy that:

a. The Congress shall be provided an annual written report by February 15 on the equipment of the RC for each of the three succeeding fiscal years (FYs), in accordance with Reference (c).

b. Procuring and distributing equipment for the RC is to be accomplished in accordance with DoDD 1225.6 (Reference (e)).

c. Responsibility for oversight of the RC shall be in accordance with DoDD 5125.01 (Reference (f)).

5. <u>RESPONSIBILITIES</u>. See Enclosure 2.

6. <u>PROCEDURES</u>. See Enclosure 3.

7. <u>INFORMATION REQUIREMENTS</u>. The NGRER is assigned Report Control Symbol DD-RA(A)1759 in accordance with DoD 8910.1-M (Reference (g)).

8. <u>RELEASABILITY</u>. UNLIMITED. This Instruction is approved for public release and is available on the Internet from the DoD Issuances Web Site at http://www.dtic.mil/whs/directives.

9. <u>EFFECTIVE DATE</u>. This Instruction is effective immediately.

# ENCLOSURE 2

# **RESPONSIBILITIES**

1. <u>ASSISTANT SECRETARY OF DEFENSE FOR RESERVE AFFAIRS (ASD(RA))</u>. The ASD(RA), under the authority, direction, and control of the Under Secretary of Defense for Personnel and Readiness, shall:

a. Forward a memorandum annually (approximately July 1) to the Military Departments and the National Guard Bureau that provides detailed instructions on preparing the current year's NGRER, including data requirements, formats, and narrative requirements.

b. Provide to the Military Departments an annual Milestone Schedule, which specifies the timetable for submission of the required inputs.

c. Obtain OSD and Military Departments' coordination and arrange for printing and distribution of the NGRER.

2. <u>SECRETARIES OF THE MILITARY DEPARTMENTS AND THE COMMANDANT OF</u> <u>THE COAST GUARD</u>. The Secretaries of the Military Departments and the Commandant of the Coast Guard shall:

a. Provide the information requested by the ASD(RA) to produce the NGRER.

b. Maintain the capability within Service data systems to provide RC programming, requirements, and inventory data needed to support the NGRER, including the capability to assess the accuracy of RC equipment procurement projections by tracking RC procurement funding from appropriation through acquisition to unit equipment delivery.

#### 3. CHIEF OF THE NATIONAL GUARD BUREAU (CNGB). The CNGB shall:

a. Provide the information requested by the ASD(RA) to produce the NGRER.

b. Provide a certification setting forth an inventory for the preceding FY of each item of equipment for which funds were appropriated; which was due to be procured for the National Guard in that FY; and which was not received by a National Guard unit by the end of that FY.

## **ENCLOSURE 3**

#### PROCEDURES

The annual report submitted to the Congress shall, at a minimum, provide the following information:

a. The Military Departments' plans to maximize RC equipment availability in accordance with Reference (e).

b. Recommendations as to the quantity and type of each major item of equipment (MIE) that should be in the inventory of the RC.

c. The quantity and average age of each type of MIE expected to be physically in the inventory of the RC at the beginning of each FY covered by the report.

d. The quantity and cost of each type of MIE expected to be procured for the RC from commercial sources or to be transferred to the RC from the Active Components (ACs).

e. The quantity of each type of MIE expected to be retired, decommissioned, transferred, or otherwise removed from the physical inventory of the RC, and replacement plans for that equipment.

f. The full wartime requirement of each type of MIE required by the RC and the quantity of each such item in the RC inventory at the end of the third succeeding FY.

g. The quantity of Service-authorized substitutes for each type of MIE in the inventory of the RC, and an indication whether the substitute is deployable in time of war.

h. A narrative explanation of the plan of each Military Department to provide equipment needed to fill the RC wartime requirement of each MIE, including an explanation of the plan to equip RC units that are short of major items at the outset of war.

i. For each MIE listed as a planned RC procurement or AC to RC transfer in the NGRER submitted to Congress 3 years prior to the current NGRER (e.g., for the FY 2010 NGRER, the MIEs listed in the FY 2007 NGRER), the quantity actually procured or transferred.

j. A statement of the current status of the compatibility and interoperability of equipment between the RC and AC, the effect of that level of incompatibility or lack of interoperability on combat effectiveness, and a plan to achieve full equipment compatibility or interoperability.

k. An assessment of the extent to which the National Guard possesses the equipment required to perform the responsibilities of the National Guard in response to an emergency or major disaster. Assessment shall identify any equipment shortfalls likely to affect the ability of the National Guard to perform these responsibilities, evaluate the effect of any such shortfall, and identify the requirements and investment strategies for equipment to reduce or eliminate the shortfall.

l. The report shall use the same format and provide the same level of detail as the information presented in the annual Future Years Defense Program Procurement Annex in accordance with DoD 7000.14-R (Reference (h)).

m. For the Army and Air National Guard MIEs listed in the NGRER submitted to Congress 3 years prior to the current NGRER (e.g., for the FY 2010 NGRER, the MIEs listed in the FY 2007 NGRER), a statement of the accuracy of the inventory projections for the third succeeding FY, and an explanation if the projection was not met.

n. A certification from the CNGB setting forth an inventory for the preceding FY of each item of equipment for which funds were appropriated; which was due to be procured for the National Guard in that FY; and which was not received by a National Guard unit by the end of that FY.

# GLOSSARY

# **DEFINITIONS**

These terms and their definitions are for the purpose of this Instruction.

 $\underline{AC}$ . The Army, the Navy, the Air Force, the Marine Corps, and the Coast Guard without their RC.

<u>compatibility</u>. Capability of two or more items or components of equipment or materiel to exist or function in the same system or environment without mutual interference.

interoperability. The ability to operate in synergy in the execution of assigned tasks.

<u>MIE</u>. Aircraft, tanks, ships, trucks, engineer equipment, and major items of support equipment. Major items of equipment should include major weapon systems, items with large dollar-value requirements or shortages, RC procurement program items and National Guard and Reserve Equipment Appropriations procurement items, as well as any RC-specific item highlighted in the narrative.

<u>on-hand</u>. Total quantity of an item of equipment currently in the inventory of a specific unit or component.

<u>requirement</u>. Capability or total quantity of an item of equipment required to be on-hand or available to meet wartime requirements at the outset of war.

<u>RCs</u>. The Army National Guard of the United States, the Army Reserve, the Naval Reserve, the Marine Corps Reserve, the Air National Guard of the United States, the Air Force Reserve, and the Coast Guard Reserve.

<u>substitute for a major item</u>. An item or capability that is authorized by the Service to be used as a substitute for a required MIE when sufficient quantities of the required MIE are not available.
