The Grand Jury Charges:

Count One

Conspiracy to Possess with Intent to Distribute a Controlled Substance (Violation of 21 U.S.C. § 846)

Beginning in or about July 2011, the exact date being unknown to the Grand Jury, and continuing to on or about December 14, 2011, in the Dallas Division of the Northern District of Texas, and elsewhere, the defendants, **Samuel George Hurd, III and Toby Lujan**, did knowingly, intentionally and unlawfully combine, conspire, confederate, and agree together, and with other persons known and unknown to the Grand Jury, to possess with the intent to distribute five kilograms or more of a mixture or substance containing a detectable amount of cocaine, a Schedule II controlled substance, in violation of 21

U.S.C. § 841(a)(1) and (b)(1)(A)(ii)(II).

In violation of 21 U.S.C. § 846.

Count Two

Attempt to Possess with Intent to Distribute a Controlled Substance (Violation of 21 U.S.C. § 846)

On or about December 14, 2011, in the Dallas Division of the Northern District of

Texas, and elsewhere, the defendants, Samuel George Hurd, III and Toby Lujan, did knowingly and intentionally attempt to possess with intent to distribute 500 or more grams of a mixture and substance containing a detectable amount of cocaine, a Schedule II controlled substance, in violation of 21 U.S.C. § 841(b)(1)(B)(ii)(II).

In violation of 21 U.S.C. § 846.

Forfeiture Notice (21 U.S.C.§ 853(a))

Upon conviction of either of the offenses alleged in Count One or Two of this Indictment, the defendants, Samuel George Hurd, III and Toby Lujan, shall forfeit to the United States all property, real or personal, constituting, or derived from, the proceeds obtained, directly or indirectly, as a result of the respective offense; and any property, real or personal, used or intended to be used, in any manner or part, to commit or to facilitate the commission of the respective offense. This property includes, but is not limited to, the following:

- (1) \$88,000 in United States currency seized from Toby Lujan on July 27, 2011.
- (2) A 2010 Cadillac Escalade, VIN: 1GYUKCEFXAR259113, seized from Samuel George Hurd, III on December 14, 2011.
