



## ***Military Service in the United States Colored Troops (USCT) during the Civil War, 1863–1866***

In 1863 in response to President Abraham Lincoln's Emancipation Proclamation the United States Army began to organize and recruit regiments of African-Americans (both freemen and former slaves) as the United States Colored Troops (USCT). Some USCT regiments originated as state militias that were established before 1863. Those of Massachusetts and Connecticut (such as the 54th Massachusetts Volunteers) remained separate, while Louisiana regiments (Native Guards and *Corps d'Afrique*) had reorganized as USCT organizations by late 1864. The USCT included cavalry, artillery, infantry, and engineering units. Most USCT soldiers served as privates and non-commissioned officers, although about 75 soldiers also received field promotions to junior officers.

### **Compiled Military Service Records (CMSRs)**

In the 1890s, the Department of War used numerous sources, such as muster rolls, descriptive rolls, and pay rolls to create compiled military service records. These records generally show when a soldier joined a unit and if he was present when the unit was mustered.

#### **CMSRs on Microfilm**

## **Other Records**

Arranged alphabetically by State or Territory, then by type of unit (cavalry, artillery, or infantry), followed by militia, reserves, sharpshooters, and other organizations. The U.S. Colored Troops appear on rolls 204–217.

Series II, Vols. 77–79 cover USCT organizations, arranged by unit. In the Index (Se–Z), pages 5297–5303 refer to the USCT in the *Official Records*. This publication is

\_\_\_M858, *The Negro in the Military Service of the United States, 1639–1886*. 5 rolls. DP. Arranged chronologically. This publication reproduces historical extracts and official papers compiled by the Adjutant General's Office concerning the military service of African Americans from the colonial period through the Civil War.

\_\_\_M1894, *Descriptive Recruitment Lists of Volunteers for the United States Colored Troops for the State of Missouri, 1863–1865*. 6 rolls. DP. Arranged alphabetically by recruiting station, then chronologically by date of enlistment, this publication reproduces 55 recruitment books and 3 indexes. The records document 8,000 African Americans from Missouri who enlisted in the 18th, 60th, 62nd, 65th, and 68th USCT, and provide such information as the recruit's name, physical description, place of birth by county or state, occupation at the time of recruitment, details (when and where recruited), recruitment officer's name, period of service, and former slave owner's name and residence by county or state.

## **Pensions**

Pension applications and records of pension payments for veterans, their widows, and heirs are based on service in the armed forces of the United States. These files can contain supporting documents such as narratives of events during service, marriage certificates, birth records, death certificates, family letters, statements from witnesses, and affidavits.

A veteran's pension file can include his rank, place of residence, age or date of birth, and time of service. A widow's application can also include her place of residence, her maiden name, the date and place of marriage, the date and place of her husband's death, and the names of children under 16. A child's or heir's file contains information about both the veteran and the widow, as well as the child's place of residence, date of birth, and the date and place of the widow's death.

These records have not been filmed and in some cases must be requested from the Veterans Administration.

## **Textual Records**

Many records pertaining to the USCT exist only in textual form. Compiled by the Colored Troops Division of the Adjutant General's Office (RG 94), these records pertain primarily to the recruitment, organization, and service of black troops and their officers. Typical records include registers of applications of officers of colored troops, registers and rosters of officers, registers of colored enlistments, record of regiments of U.S. Colored Troops, and descriptive lists of colored volunteers.
