In response to this challenge, the Department of Health and Humans Services Substance Abuse and Mental Health Services Administration (SAMHSA) is providing a new toolkit that teaches staff working in senior living communities how to recognize and take steps to help someone at risk of suicide. The ideas presented in this toolkit can help prevent suicides, promote mental health, and create an environment that will enhance the well-being of residents and staff alike.

## Applications Are Being Accepted for the Third Annual Rosalinde Gilbert Innovations in Alzheimer's Disease Caregiving Legacy Awards

Initiated in 2007, The Rosalinde Gilbert Innovations in Alzheimer's Disease Caregiver Legacy Award is intended to promote promising practices and stimulate innovation in the field of Alzheimer's caregiving by recognizing and

rewarding those efforts which lead the way in addressing the needs of Alzheimer's caregivers.

Three awards of \$20,000 each will be awarded to *nonprofit organizations*, government agencies or *universities* responding to a community need with a program or project which focuses primarily on *family/informal caregivers of adults with Alzheimer's disease and related dementias*. One award will be granted in each of three categories: (1) Creative Expression, (2) Policy and Advocacy and (3) Diverse/Multicultural Communities.

## The application deadline is 5 p.m. Pacific Time August 12, 2010.

### NCOA Offers Two New Tools for Seniors in Need of Benefits

The National Council on Aging's National Center for Benefits Outreach & Enrollment (NCBOE) has developed a new data mapping tool that allows users to search for information about eligibility and enrollment trends in Medicare and Medicaid benefits programs. The map also provides statistics on the number of individuals eligible for or enrolled in programs such as Medicare Part D Extra Help.
