CMS Awards Grants to Six States to Combat Abuse and Neglect in Long Term Care Facilities

In a move aimed at combating abuse and neglect in the nation's long-term care facilities, the Centers for Medicare & Medicaid Services (CMS) has awarded more than \$13 million to six states to design comprehensive applicant criminal background check programs for jobs involving direct patient care. The first round of states to participate in the program are: Alaska, Connecticut, Delaware, Florida, Missouri, and Rhode Island. They each will share a portion of \$13.7 million.

An additional 11 states applied and may be funded beginning in October or November. CMS will also issue a second solicitation in October for those states that did not apply but may still do so.

"The new health care law will help states identify the best, most effective ways to determine which applicants can be trusted with the health and safety of residents and which cannot," said Donald M. Berwick, M.D., CMS administrator.

Created by the Affordable Care Act, the new National Background Check Program will help identify "best practices" for long-term care providers to determine whether a job seeker has any kind of criminal history or other disqualifying information that could make him or her unsuitable to work directly with residents.

Information on Peripheral Arterial Disease Added to NIHSeniorHealth Website

Information about the risk factors, diagnosis and treatment of peripheral arterial disease, or P.A.D., was added to NIHSeniorHealth, the senior-friendly health and wellness website from the National Institutes of Health. Consumers can visit www.nihseniorhealth.gov/peripheralarterialdisease/toc.html to learn more about P.A.D., which develops when arteries in the body become clogged with fatty deposits, limiting blood flow. P.A.D. affects an estimated 8 million to 12 million people, most of them over age 50.

Information about P.A.D. is the latest addition to the roster of health topics offered on NIHSeniorHealth. A joint effort of the National Institute on Aging (NIA) and the National Library of Medicine (NLM), the website features

research-based, easily accessible information on a range of health issues of interest to older people. Topics include ways to exercise properly, safe use of medicines, and management of diseases such as stroke, diabetes, osteoporosis, and Alzheimer's disease. To improve access for older adults, NIHSeniorHealth includes short, easy-to-read segments of information in a number of formats, including various large-print type sizes, open-captioned videos, and an audio version.

Health and Human Services Secretary Kathleen Sebelius recently announced the launch of HealthCare.gov on Facebook. HealthCare.gov on Facebook provides additional resources that allow consumers to take health care into their own hands. It allows people to: Search for insurance coverage using our "Insurance Finder" tool. The tool asks users to fill out two fields with basic information about themselves and the state they live in. Users are then redirected to a page on HealthCare.gov that continues with the insurance finder process based on the information provided. Users are also able to share thoughts and ideas with other members of the HealthCare.gov network and learn more about what the Affordable Care Act means for individuals, families, or small businesses.

HHS Releases \$101 Million in Emergency Funding to States for Energy Assistance

US Department of Health and Human Services Secretary Kathleen Sebelius recently announced the release of \$101 million in emergency contingency funding to help eligible low-income homeowners and renters meet their home energy needs. These Low-Income Home Energy Assistance Program (LIHEAP) contingency funds will provide states, territories, tribes and the District of Columbia with additional assistance to pay heating and cooling costs. Funds will be allocated to all states based on their regular (old) block grant allocations.

Nationwide System to Assist Doctors and Hospitals in Switching to Electronic Health Records Is Completed

David Blumenthal, M.D., national coordinator for health information technology, recently announced selection of the final Regional Extension Centers (RECs), completing a national system of 62 organizations that will help physicians, clinics and hospitals to move from paper-based medical records to electronic health records (EHR).

Two new awardees were named to cover Orange County, Calif., and the state of New Hampshire. In addition, service areas were expanded for two alreadynamed Florida RECs, completing RECs coverage of all areas of the country.

RECs were created last year under the Health Information Technology Economic and Clinical Health (HITECH) Act, part of the American Recovery and Reinvestment Act of 2009. HITECH provided approximately \$2 billion in new programs to provide training and technical assistance and to demonstrate the effectiveness of health information technology in supporting improvement in care. Under the HITECH Act, \$677 million is allocated for the next two years to support a nationwide system of RECs.

HHS Awards \$68 million in Grants to Support Community Living for Seniors and Individuals with Disabilities

HHS Secretary Kathleen Sebelius recently announced \$68 million in grants to help seniors, individuals with disabilities, and caregivers better understand and navigate their health and long-term care options. These grants are being administered collaboratively by HHS' Administration on Aging (AoA) and the Centers for Medicare & Medicaid Services (CMS).

In making the announcement, Sebelius remarked "We know how difficult it can be for individuals and caregivers to deal with a sudden illness or chronic disease while at the same time trying to navigate through a complex health care system to figure out where to go to get appropriate help. The Affordable Care Act seeks to give people more control over their own care, while lowering health care costs and improving quality."

The funds will be used to help families: understand their Medicare and Medicaid benefits, including coverage for preventive services; navigate options for long term care including community-based services that can help individuals remain in their homes; and assist those transitioning from nursing or rehabilitation facilities back home to put the supports in place to make that transition successful.

Rural Health Network Development Grant Program

The Department of Health and Human Services' Health Resources and Services Administration (HRSA) will award 25 grants to support rural providers who work in formal networks, alliances, coalitions or partnerships to integrate administrative, clinical, technological, and financial functions. The ultimate goal of the Rural Health Network Development Grant Program is to strengthen the rural health care delivery system by 1) improving the viability of the individual providers in the network, and/or 2) improving the delivery of care to people served by the network. to expand access to, coordinate and improve the quality of essential health care services, and enhance the delivery of health care in rural areas.

The amount of each grant will be \$180,000.00. The application deadline is November 12, 2010, 8:00 PM EST.

Second Opportunity for National Background Check Program Funding

The Centers for Medicare & Medicaid Services (CMS) will give a second opportunity to States and U.S. Territories that did not have adequate time to respond to its June 4, 2010 solicitation for Federal matching grants for a multi-year National Background Check Program for Patient Protection for direct patient access employees of several long term care facilities and providers. This second chance is in response to a number of states that indicated they were interested but unable to meet the August 9, 2010 deadline.

CMS is now giving advance notice that in early October 2010 it will issue a second solicitation to allow those States that did not have adequate time to complete their application an opportunity to participate in the grant program. CMS encourages all States that have not applied, but may be interested in doing so, to take this opportunity to continue their planning efforts.

Further information about the National Background Check Program will be posted to the CMS website in October. It is expected to be nearly identical to the initial solicitation. USDA Awards Grants to Expand Nutrition Aid for Low-Income Seniors

Agriculture Secretary Tom Vilsack recently announced that US Department of Agriculture (USDA) has awarded \$3.1 million to three States to increase access and participation in the Supplemental Nutrition Assistance Program (SNAP) among low-income seniors. The grants fund pilot projects to increase SNAP participation among Medicare's Extra Help population. Extra Help, also known as the Low Income Subsidy, helps low-income individuals or couples with limited resources pay for their Medicare prescriptions.

Winning projects include an outreach effort in Washington State to simplify applications for seniors. Pennsylvania will build on a current partnership that

streamlines the SNAP application and fast-tracks the eligibility process. And New Mexico's pilot standardizes benefits for the Extra Help population. Washington will receive \$1 million to conduct outreach in two counties. Washington's activities include a simplified application for seniors, intensive media campaign, targeted mailings, follow-up through phone calls and home visits, and a mobile SNAP office.
