National Influenza Vaccination Week - December 4-10

Spread the word, not the flu

Anyone can get Influenza (the flu), and anyone can give the flu to someone else. The flu can be a serious disease that can lead to hospitalization and sometimes even death. The good news is that according to the CDC, in recent years the highest rates of vaccination have been among those over 65.

But we still need to do more. Older adults with a chronic illness such as diabetes are at greater risk of serious complications from the flu compared with young, healthy adults. The Centers for Disease Control and Prevention (CDC) estimates that 90 percent of seasonal flu-related deaths and more than 60 percent of seasonal flu-related hospitalizations in the US each year occur in people 65 years and older.

CDC records indicate that approximately 72 percent of persons 65 and older received the seasonal vaccination in 2010. However, that percentage is not where it should be among groups that have traditionally been hard to reach. Within that percentage, the numbers shift downward dramatically to 52 percent among Asian Americans, 43 percent among non-White Hispanics and not quite 40 percent among African Americans. These numbers are in despite of Medicare's coverage of flu vaccines at no out-of-pocket cost to beneficiaries.

The flu is a vaccine-preventable disease. Reducing disparities in flu vaccination is a health and wellness priority. The Aging Network can be an important vehicle to ensure that older adults get vaccinated. The Federal government website Flu.gov at http://www.flu.gov provides an abundance of outreach materials to launch a flu vaccination campaign. At the website visitors can also search the Flu Vaccine Finder to find information about local vaccine sites. You can also learn about what others are doing to prevent the flu in their communities.

ASA Greenlee to Speak at the HUD LGBT Housing Summit

Assistant Secretary for Aging Kathy Greenlee will give closing remarks at the Housing and Urban Development (HUD) LGBT Housing Summit. The Summit will be held on December 7th, in Washington, DC.

LGBT elders often face discrimination and legal barriers to accessing housing and long-term care and are more likely to age without the benefits of a partner and/or children and other family supports compared to other elders. Recognizing the housing problems for LGBT older adults of all income levels, the HUD in partnership with the Administration on Aging, Department of Health and Human Services, and the National Center for Lesbian Rights are cohosting the summit to address this issue.

The summit will bring together advocates and practitioners from across the country to highlight existing barriers, as well as explore future possibilities for promoting current efforts to support housing and long-term care designed for LGBT elders.

Funding Opportunities

New Funding Opportunity for Mobility Management

The National Center for Senior Transportation (NCST) is requesting proposals for mobility management projects that demonstrate innovative and effective solutions to enhance transportation options for older adults through personcentered mobility management. Non-profit or local/regional/Tribal governmental agencies that plan, administer or provide aging and/or transportation services may apply. Four categories of projects will be funded:

- Peer-mobility management and employment;
- Mobility management in rural/frontier areas that have limited transportation options;
- Holistic models that integrate mobility management within current practices, including options counseling, information and assistance and/or case management; and
- Mobility management applied to the family of senior transportation options.

The NCST expects to award eight grants with a maximum award of \$50,000 each. Matching funds are not required. Grantees will be expected to complete their work in 9-12 months. The focus of all the grants is on older adults, although projects may also target adults with disabilities. A focus on culturally and ethnically diverse older adults is strongly encouraged.

Involvement of State Aging and Disability Advocates in Duals Integration

Date: Friday, December 9, 2011 Time: 2:00 p.m. ET - 3:30 p.m. ET

Approximately 9 million low-income seniors and younger persons with disabilities are enrolled in both Medicare and Medicaid (often referred to as "duals"). Many states are pursuing efforts to better coordinate care and

potentially lower costs for this population. Earlier this year, 15 states were awarded design contracts of up to \$1 million each to develop service delivery and payment models that integrate care. More broadly, 38 states and the District of Columbia have submitted letters of intent to pursue opportunities for integration announced by the Centers for Medicare and Medicaid Services (CMS) in July.

This webinar will provide a basic overview of the duals population, activity within states, opportunities and concerns, and stakeholder involvement. It is sponsored by the Friday Morning Collaborative, a coalition of national aging and disability organizations working together to protect and strengthen Medicaid home and community based services.

Medicare December 7 Open Enrollment Deadline Nears

Ongoing resources are available for seniors and people with disabilities to compare coverage options.

As the December 7th deadline grows closer for people with Medicare to change or choose their drug and health plan coverage for next year, the Centers for Medicare and Medicaid Services (CMS) and its network of partners and advocates are available to assist with counseling and enrolling beneficiaries on their choices for 2012. With just days remaining in the Annual Enrollment Period, beneficiaries, their families and representatives should contact Medicare's consumer resources—http://www.medicare.gov and 1-800-MEDICARE—for assistance.

"Before the December 7th deadline, we urge all people with Medicare to focus on Open Enrollment and compare costs, coverage and their satisfaction with their current coverage with options for 2012," said CMS Administrator Donald M. Berwick, M.D. . "Once you compare plans, if your current plan satisfies your needs for next year, you don't need to do anything. If other options are a better match for your needs, there is still time to change."

Federal Interagency Task Force on the Arts and Human Development Launched

On November 30th, Assistant Secretary for Aging Kathy Greenlee participated in a webinar hosted by the National Endowment for the Arts (NEA) to announce a new Federal Interagency Task Force on the Arts and Human Development. This task force, of which the Administration on Aging is a member, will work to encourage more and better research on how the arts help people reach their full potential at all stages of life.

The task force is a result of *The Arts and Human Development*, a white paper that proposes a framework for long-term collaboration among federal agencies to build capacity for future research and evidence sharing about the arts' role in human development. The white paper stems from a first-ever convening between the NEA and the Department of Health and Human Services in March

2011 in Washington, DC with NEA Chairman Rocco Landesman and Health and Human Services Secretary Kathleen Sebelius.

States Receive More Flexibility, Resources to Implement Affordable Insurance Exchanges

More than half of states now creating marketplaces to help millions of families and small businesses buy insurance

The Department of Health and Human Services (HHS) recently awarded nearly \$220 million in Affordable Insurance Exchange grants to 13 states to help them create Exchanges, giving these states more flexibility and resources to implement the Affordable Care Act. The health care reform law gives states the freedom to design Affordable Insurance Exchanges – one-stop marketplaces where consumers can choose a private health insurance plan that fits their health needs and have the same kinds of insurance choices as members of Congress.

The Department also released several Frequently Asked Questions providing answers to key questions states need to know as they work to set up these new marketplaces. Critical among these are that states that run Exchanges have more options than originally proposed when it comes to determining eligibility for tax credits and Medicaid. And states have more time to apply for "Level One" Exchange grants.
