Medicare Beneficiaries See Significant Savings in 2011

Nearly three million people with Medicare receiving discounts on prescription drugs, 24.2 million receiving free preventive care

The Centers for Medicare & Medicaid Services (CMS) recently announced that as of the end of October, more seniors and people with disabilities on Medicare have seen significantly lower costs for important health care – through both

discounts on brand-name drugs in the Medicare Part D "donut hole" coverage gap and free preventive care. "Thanks to the Affordable Care Act, millions of Americans are receiving free preventive services and getting cheaper prescription drugs," said Acting CMS Administrator Marilyn Tavenner.

Data show that 2.65 million people with Medicare have saved more than \$1.5 billion on their prescriptions – averaging about \$569 per person. And, as of the end of November, more than 24.2 million people with Medicare have taken advantage of at least one free preventive benefit – including the new Annual Wellness Visit – made possible by the Affordable Care Act.

CMS Rule Gives Employers and Consumers Access to Quality Healthcare Data

As a part of the Affordable Care Act, the Centers for Medicare & Medicaid Services (CMS) recently announced a final rule that gives employers and consumers access to information they need to make more informed choices about their healthcare.

The rule gives qualified organizations, like employers and consumer groups, access to data that can help them identify high quality healthcare providers or create online tools to help consumers make educated healthcare choices. Information that could identify specific patients, however, will not be publicly released and strong penalties will be in place for any misuse of data.
