Celebrated around the world on December 1st, World AIDS Day provides an opportunity to raise awareness and bring attention to the importance of HIV/AIDS prevention and treatment. 2011 marks the **30th anniversary** of the first reported case of AIDS in the U.S. According to the most recent Centers for Disease Control and Prevention (CDC) data, people over the age of 50 account for 17 percent of new HIV diagnoses and 31 percent of persons living with an HIV diagnosis.

We encourage the Aging Services Network to participate in World AIDS Day activities to raise awareness about HIV/AIDS among older adults and their caregivers. By working collaboratively with HIV care providers to educate older Americans about the prevention of HIV, you can help to ensure that the special needs of the older men and women living with HIV can be effectively addressed in an integrated and coordinated fashion.

CMS Awards Grants to Expand 52 Senior Medicare Patrol Programs

The US Department of Health and Human Services (HHS) announced on November 22^{nd} the award of \$9 million from the Centers for Medicare & Medicaid Services (CMS) to help Senior Medicare Patrol (SMP) programs across the nation continue their work fighting Medicare fraud. This is part of President Obama's initiative to educate people with Medicare about how to protect themselves and Medicare from fraud. The grants will provide additional funds for SMPs to increase awareness among Medicare beneficiaries about how to prevent, detect and report health care fraud. Increased funding levels for states identified with high-fraud areas will support additional targeted strategies for collaboration, media outreach and referrals.

The Administration on Aging (AoA) will continue to administer these grants in partnership with CMS. "This demonstrates AoA's and CMS' shared commitment to educate beneficiaries so they can protect themselves and Medicare as a whole," said Assistant Secretary for Aging Kathy Greenlee. "I thank the Centers for Medicare & Medicaid Services for their continued partnership in this effort to educate seniors about health care fraud."

The volunteers work in their communities to educate Medicare beneficiaries, family members, and caregivers about the importance of reviewing their Medicare notices, and Medicaid claims if dually-eligible, to identify errors and potentially fraudulent activity.

Earlier this year, the Department of Health and Human Services (HHS) Secretary Kathleen Sebelius and NEA Chairman Rocco Landesman convened a day-long research summit to explore the role of the arts and human development across the life span. The resulting published white paper pointed to many studies that have found links between the arts and positive cognitive, behavioral and social outcomes. However, it was noted that most of this research is small-scale and short-term, leaving major gaps in federally sponsored research on the role of the arts in human development. The white paper calls for the establishment of a federal interagency task force to address those gaps and to build a community of researchers working in this area. The goals of the task force, which will include representatives from more than a dozen federal agencies, will be detailed in the webinar.

NASUAD Launches Online Training Course for I&R/A Professionals

The National Association of States United for Aging and Disabilities (NASUAD) has launched a new online training course, *Basic Training for Aging I&R/A Professionals*. The course features four modules that aim to enhance the services provided by Aging Information and Referral/Assistance (I&R/A) professionals by advancing their knowledge, skills, and work-related competences. The course is also carefully designed to help prepare I&R/A

professionals to obtain a certification in CIRS-A (Certified Information and Referral Specialist-Aging).

Participants in the course will learn about the historical expansion of the Aging Network and the development of Aging I&R/A; an overview of the broad array of health, social and long-term services and supports for seniors and individuals with disabilities; tools and strategies to provide culturally appropriate services; and the fundamental phases of the I&R/A process with a focus on learning how to support the decision making of seniors, individuals with disabilities, and their caregivers.

This new online training platform offers video tutorials, concise written materials, voice narrated PowerPoints, and online quizzes that allow participants to demonstrate their understanding of each module's learning objectives. Participants that successfully complete the course, scoring 75 percent or greater in the quizzes, will receive a Certificate of Completion.

Electronic Prescriptions on the Rise, but Barriers Remain

"Transmitting and Processing Electronic Prescriptions: Experiences of Physician Practices and Pharmacies," a study recently published online in the *Journal of American Medical Informatics Association*, concludes that while electronic transmission of new prescriptions has matured, changes in technical standards and system design and more targeted physician and pharmacy training may be needed to address barriers to e-renewals, mail-order pharmacy connectivity and pharmacy processing of e-prescriptions.
